RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO SIGN IN THE DEED OF DONATION OF LOT NO. 2171 WITH AN AREAQ OF FIVE THOUSAND SEVEN HUMDRED AND SIXTY THREE (5,763) SQUARE METERS MORE OR LESS IN FAVOR OF THE MINA CENTRAL SCHOOL DISTRICT OF MINA, DIVISION OF ILOILO, DEPARTMENT OF EDUCATION

WHEREAS, the Office of the mayor received a letter from Mr. John T. Gonzales, Principal II, Mina Central School requesting for a resolution authorizing the Honorable Mayor to sign in the Deed of Donation of the subject lot described as lot No. 2171 with an area of 5,763 square meters more or less in favor of the Mina Central School in compliance with the Memorandum of Agreement (MOA) between the Department of Education (DepEd) and Department of Environmental Natural Resources (DENR) duly signed by their respective Secretaries, and Section 4 of Republic Act 10023 requiring the issuance of Special Patent or Title to the land occupied by public buildings;

WHEREAS, lot 2171 is a public land registered in the name of the Municipality of Pototan, and now belongs to mina where this particular lot is located, as evidence by Original Certificate of Title (OCT) No. 69426 dated 21st day of August 1918, hereto attached;

WHEREAS, the subject lot could never be donated by the Municipality represented by the Municipal Mayor in favor of the Mina Central School unless there is an authority to sign by the Mayor himself coming from Sanggunian, hence this Resolution.

NOW, THEREFORE:
