RESOLUTION APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2016-001, RE: REQUESTING FOR THE REALIGNMENT OF TWO MILLION PESOS (P2,000,000.00) FROM THE 2014 20% DEVELOPMENT FUND CONTINUING APPROPRIATION – P965,582.10 FOR HEALTH CARE FINANCING AND 2015 20% DEVELOPMENT FUND CONTINUING APPROPRIATION – P1,034,417.90 TO DEFRAY EXPENSES FOR THE SITE DEVELOPMENT OF THE HOUSING PROJECT (PABAHAY NG MINA) FINANCED BY THE NATIONAL HOUSING AUTHORITY (NHA)

WHEREAS, presented to this Honorable Body for consideration and approval was the Municipal Development Council (MDC) Resolution No. 2016-001, re; REQUESTING FOR THE REALIGNMENT OF TWO MILLION PESOS (P2,000,000.00) FROM THE 2014 20% DEVELOPMENT FUND CONTINUING APPROPRIATION – P965,582.10 FOR HEALTH CARE FINANCING AND 2015 20% DEVELOPMENT FUND CONTINUING APPROPRIATION – P1,034,417.90 TO DEFRAY EXPENSES FOR THE SITE DEVELOPMENT OF THE HOUSING PROJECT (PABAHAY NG MINA) FINANCED BY THE NATIONAL HOUSING AUTHORITY (NHA);
