**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO THE CONTRACT OF LABOR SERVICES WITH MR. SULFICIO TIMTIMAN, JR., OF MANDURRIAO, ILOILO CITY, PAKYAW LEADER, FOR THE LABOR SERVICES OF THE CONSTRUCTION OF EVACUATION CENTER, PHASE II IN THE AMOUNT OF P 132, 994.99 FROM THE LOCAL COUNTERPART**

**WHEREAS**, the Municipality of Mina has appropriated its Local Counterpart for the completion evacuation center, Phase II amounting to Five Hundred Thousand Pesos (P500,000.00);

**WHEREAS**, the project implementation shall be undertaken by way of administration by which the labor component was awarded to the winning Pakyaw Contractor led by certain Sulficio Timtiman Jr., of Mandurriao, Iloilo City in the amount of P 132, 994.99;

**WHEREAS**, in view of the aforementioned, a Contract of Labor Services to be executed and signed by both parties is needed, in which an authority to sign by the Municipal Mayor from this Honorable Body is needed pursuant to the provisions of RA 7160.

**Now, therefore:**

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
