RESOLUTION AMENDING RESOLUTION NO. 2015-122, RE: RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY DIRECTOR MA. EVELYN B. MACAPOBRE, REGION VI, ILOILO CITY FOR THE IMPLEMENTATION OF THE IDENTIFIED LIVELIHOOD ASSISTANCE GRANT (LAG) IN THE MUNICIPALITY OF MINA DUE TO SOME CHANGES IN THE APPROVED AMOUNT INVOLVED IN THE AGREEMENT

WHEREAS, the DSWD is mandated to provide augmentation support to LGU and other entities in uplifting the lives of the disadvantage population who are the victims manmade and natural disaster, particularly when super typhoon Yolanda devastated the whole Visayas Region wherein means of livelihood of the populace were greatly affected resulting to widespread hunger and displacement;

**WHEREAS,** the DSWD, in attaining its mandate is willing to provide technical and financial assistance to LGUs to be conduit in the provision of basic services and implementation of its program;

**WHEREAS,** the amount of Five Million Nine Hundred Forty Four Thousand Nine Hundred Seventy One Pesos (P5,944,971.00) was approved for the Livelihood Assistance Grant (LAG) of Sustainable Livelihood Program but eventually the amount covered by the agreement was reduced to P4,739,968.00, as part of the same amounting to One Million Two Hundred Five Thousand Three Pesos (P1,200,503.00) was released in advance and was deposited to the account of various Vegetables Growers Association who are the recipients in this Municipality, at the discretion of DSWD Regional Field Office VI;

WHEREAS, the approved amount stated above was for the Skills Training in Good Agricultural practices, Harvest Management and Post-Harvest Handling in Agmanaphao, Amiroy, Bangac, Badiangan, Cabalabaguan, Capul-an, Dala, Mina East, Tolarucan&Tumay; Skills Training in Baking for identified Women's group; Enterprise Capital Assistance for Cooperative Store in Tipolo &Yugot, Enterprise Capital Assistance for Food vending in Badiangan, Mina East, Tolarucan, and Tumay; and Enterprise Capital Assistance for Hog and Goat Raising in Abat, Agmanaphao, Amiroy, Badiangan, Bangac, Cabalabaguan, Capul-an, Dala, Guibuangan, Janipa-an East, Janipa-an West, Mina East, Mina West, Nasirum, Naumuan, Singay, Talibong Grande, TalibongPequeño, Tumay&Yugot in the Municipality of Mina.
