**RESOLUTION EXTENDING COMMENDATION TO MINA PNP OPERATIVES AND SPECIAL OPERATION UNIT (SOU) “B” IPPO LED BY PI ROY DIAZ CASTRO OFFICER INCHARGE FOR A SUCCESSFUL OPERATION ON THE CAMPAIGN AGAINST ILLEGAL DRUGS AND ALL FORMS OF CRIMENALITIES**

WHEREAS, at about 5:00 o'clock in the afternoon of March 1, 2016 Intelligence operatives led by P03 Aaron Gaton and P01 Ferdinand Armada left station to conduct a buy bust operation at Brgy. Cabalabaguan, Mina, Iloilo;

WHEREAS, that at about 8:00 o'clock in the evening of same day said operatives with Special Operation Unit (SOU) and the responding team return station from Brgy. Cabalabaguan, same Municipality together with the arrested person Alfredo Acallar y Vargas “Alias Pedoy”, 50 years old, widow and a resident of Brgy. Guadalupe, Janiuay, Iloilo. Suspect was arrested in a buy bust operation at said barangay at about 7:30 o'clock in the evening of said date;

WHEREAS, as a consequence of the operation recovered from the control and possession of suspect are as follows: one (1) shoulder bag, color brown marked as AVA-9, one (1) heat sealed transparent plastic sachet with crystalline substance “Shabu” marked as AVA-1, recovered at the pocket of the shoulder bag, three (3) heat sealed transparent plastic sachet “shabu” marked as AVA-2, AVA-3 and AVA-4 placed inside the empty container of dental floss oral B marked as AVA-5, one (1) eye glass case marked as AVA-6, one (1) disposable lighter marked as AVA-7, one (1) improvised Totter marked as AVA-8, from back pocket of his pants, one black wallet with professional driver’s license, COMELEC I.D., Brgy. Kagawad ID, two (2) twenty peso bill and one (1) motorcycle. Initial inventory on seized items was conducted witness by Marlene Pelaez and Ofelio Pedrajas, Punong Barangay and Kagawad respectively. Recovered evidence and suspect are under the custody of Mina PNP Station for laboratory examination and safekeeping. Case for violation of R.A. 9165, Article II, Sec. 5, 11 and 12 was filed before the Deputy Provincial Prosecutor MA. ELENA HOFILEÑA GERACHI under I.S. No. VI-II-INQ-16C-00223 to 00223-A and 0223-B on March 2, 2016;

WHEREAS, due to well-coordinated efforts shown by both teams in carrying out their mission on anti-Drugs campaign which today are considered as one of the major crime problems proliferating in our society ended to a successful accomplishment and worthy of reward and commendation;
