**RESOLUTION REQUESTING APPROVAL AND RECOMMENDATION OF THE
SANGGUNIANG BAYAN, MUNICIPALITY OF MINA TO ESTABLISH YUGOT
PRIMARY SCHOOL AT BRGY. YUGOT, MINA, ILOILO**

WHEREAS, the putting up or the establishing of Primary School at Brgy. Yugot, Mina, Iloilo is a very laudable program. This has been the dream, and desire of the Barangay Officials and the people of Brgy. Yugot to have a school consistent with Section 16 of RA 7160;

WHEREAS, it is but timely that one of the programs identified in the 10-point agenda of the Local Chief Executive focuses on the expansion of services to the Education sector as a main avenue of developing the youth sector and school age children to their full potentials, preparing them to become competent in all fields of endeavor, and eventually, thus, making them to be useful and productive citizens of the society;

WHEREAS, the manifestation of the Brgy. Officials and the people of Brgy. Yugot for their concern, for giving importance to Education is very commendable. Their quest for knowledge through education has been answered. This was realized through the collaborative efforts of the Brgy. Officials, the Local Government Unit and the Department of Education, District of Mina. All the requirements needed for the establishment of the said school at Yugot were all complied with, particularly the acquisition of the Deed of Donation from the Lot Owner;

WHEREAS, the school at Brgy. Yugot is an extension school of Mina Central School under the Supervision of the District of Mina. It has one teacher with combination classes of Kinder II and Grade I. The compensation of the teacher is financed by the Local School Board. Hopefully, the said teacher will enjoy a national item by virtue of the Department of Education since the school is now officially recognized as Yugot Primary School;
