**WHEREAS,** to ensure success in carrying out the project, the commitment, active involvement and support of various stakeholders, particularly the provincial, municipal and barangay government is necessary.

**WHEREAS,** the parties hereto agree and declare their commitment to take the necessary steps to implement the principles and objectives provided for, in the agreement, hence this Resolution.
