RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MUNICIPALITY OF MINA AND THE INSTITUTE OF PHILIPPINE CULTURE, ATENEO DE MANILA UNIVERSITY, IN THE AVAILMENT OF “eHATID LGU” PROJECT

WHEREAS, presented for consideration to this August Body is the authority of Mayor Rey P. Grabato, to enter into and sign into a Memorandum of Understanding (MOU) between the Municipality of Mina and the Institute of Philippine Culture, Ateneo de Manila relevant in the availment of “eHATID LGU” project, consistent with Section 17 (iii) of RA 7160;

WHEREAS, the ADMU IPC has been collaborating with the province of Occidental Mindoro as one of its partners for the Philippine Council for Health Research and Development – Department of Science and Technology (PCHRD-DOST) and ADMU IPC operational research project entitled, “eHATID of LGUs – eHealth TABLET (Technology Assisted Boards for LFU Efficiency and Transparency) for Informed Decision – making of LGUs (eHATID LGU)”;

WHEREAS, “eHATID LGU” project was approved by PCHRD DOST Governing Council and falls under the National Unified Health Research Agenda (NUHRA) priority areas in Information Communication and Technology (ICT) for Health Program;

WHEREAS, the eHATID LGU project aims to integrate the PhilHealth Outpatient Benefit Package Plus (OPB+) otherwise known as the TSEKAP – Tamang Serbisyo para sa Kalusugan ng Pamilyang Pilipino electronic information system into the eHealth TABLET system as a Health Information System support for PhilHealth, to be implemented to four hundred fifty municipal and city LGUs to facilitate informed decision making and in support of the Universal Health Care/Kalusugan Pangkalahatan strategic thrusts of the Aquino Health Agenda;

WHEREAS, the LGU seeks to enhance its capability to govern, and has recognized the role of ICT to ensure effective and efficient governance and delivery of basic services to the public;

WHEREAS, the LGU has manifested its intent to be considered as one of the beneficiaries of the eHATID LGU project through the use of ICT for effective and efficient governance in the country, particularly through and eHATID LGU project;

WHEREAS, ADMU IPC and the LGU have agreed to cooperate and jointly commit in promoting community development through the use of ICT for effective and efficient governance in the country, particularly through the eHATID LGU project;

WHEREAS, a Memorandum of Understanding (MOU) is needed to identify the specific terms, conditions and working arrangements needed in the implementation of the activities that will enhance coordination and assistance in the conduct of the eHATID LGU project.

NOW, THEREFORE:

Be it resolved by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MUNICIPALITY OF MINA AND THE INSTITUTE OF PHILIPPINE CULTURE, ATENEO DE MANILA UNIVERSITY, IN THE AVAILMENT OF “eHATID LGU” PROJECT IN THE MUNICIPALITY OF MINA.
