RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) REPRESENTING THE LGU-MINA WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REPRESENTED BY REBECCA P. GEAMALA, OIC-REGIONAL DIRECTOR, FIELD OFFICE VI AND THE SENIOR CITIZEN'S ASSOCIATION, MINA CHAPTER REPRESENTED BY VIRGINIA BORRA, SENIOR CITIZENS PRESIDENT, FOR THE Bottom-Up Budgeting (BuB) PROGRAMS/PROJECTS IMPLEMENTATION IN THE MUNICIPALITY OF MINA

WHEREAS, presented for consideration to this August Body is the authority of Mayor Rey P. Grabato, to enter into and sign into a Memorandum of Agreement (MOA) representing the Municipality of Mina with DSWD Region VI, represented by Rebecca P. Geamala, OIC-Regional Director, DSWD field Office VI, Iloilo City and the Senior Citizens Association, a Civil Society Organization, Senior Citizens in the Municipality of Mina, for Bottom-up Budgeting programs/projects implementation in the Municipality of Mina;

WHEREAS, the Bottom-up Budgeting which aims to make the planning and budgeting processes of both local and national government more particularly, by involving grassroots communities in the delivery of national services to poor communities be adapted by different National Agencies and Local Government Agencies as part of their poverty reduction effort;

WHEREAS, pursuant to the DBM, DILG, DSWD, and NAPC issued Joint Memorandum Circular 03 series of 2012 (JMC 03 s. 2012), specifying the guidelines for implementation and monitoring of Bottom-up Budgeting projects for FY 2016, both the DSWD and Local Government Units and or CSOs shall uphold the principle of people empowerment even during the course of and post project implementation;

WHEREAS, the DSWD, through the Regional Project Management Offices shall manage the review and assessment of projects and approval and disbursement of Botom-up Budgeting funds to the respective eligible LGUs and CSOs to implement the Bottom-up Budgeting projects as stipulated in the DSWD Administrative Order No. 05;

WHEREAS, R.A 7160 otherwise known as the Local Government Code of 1991, provides that, the Municipal Mayor may represent the Municipality and sign in its behalf in contract, obligations and other documents upon authorization by the Sangguniang Bayan, hence this Resolution.

NOW, THEREFORE:
