**RESOLUTION AUTHORIZING THE HON. REY P. GRABATO, MUNICIPAL
MAYOR, MINA, ILOILO TO ENTER AND SIGN INTO A MEMORANDUM OF
AGREEMENT (MOA) WITH THE NATIONAL HOUSING AUTHORITY (NHA)
REPRESENTED BY ITS GENERAL MANAGER, ATTY. SINFOROSO R. PAGUNSAN
WITH OFFICE ADDRESS AT NHA BUILDING, ELLIPTICAL ROAD, DILIMAN,
QUEZON CITY FOR THE IMPLEMENTATION OF THE RESETTLEMENT
ASSISTANCE PROGRAM FOR THE MUNICIPALITY OF MINA**

WHEREAS, presented for consideration is the letter from the Office of the Mayor requesting for an authority to sign in the MOA for the implementation of the Resettlement Assistance Program extended by the National Housing Authority (NHA) to this Municipality;

WHEREAS, pursuant to Executive Order No. 90, dated December 17, 1980, the National Housing Authority is the sole national government agency engaged in direct housing production mandated to meet the housing needs of the low and marginal income families and to focus its efforts towards the housing needs of the lowest 30% of the urban population;

WHEREAS, pursuant to the Local Government Code of 1991 and the Urban Development and Housing Act (RA 7279), Local Government Units (LGUs) are mandated to take a principal role in the provision of housing to their constituents;

WHEREAS, pursuant to Board Resolution No. 5436 dated 30 March 2012 and Memorandum Circular No. 2427 dated 26 April 2012 on the Revised Guidelines for the Implementation of the Resettlement Assistance Program for Local Government Units”, the NHA shall provide assistance to local government units the development of housing sites for informal settler families requiring relocation and resettlement;

WHEREAS, there is an immediate need to establish a resettlement project in the Municipality of Mina, to accommodate informal settlers families living along Suague River that is constantly affected by flooding brought about by typhoons and other qualified urban poor families qualified for relocation and resettlement assistance under RA 7279;

WHEREAS, the Municipality owns a land with an aggregate area of 1,515 sq. m. located at Brgy. Poblacion, Mina, Iloilo covered by TCT No. 124511 registered in the name of the MUNICIPALITY with the Registry of Deeds for the Province of Iloilo hereto attached as Annex “A” and designated the same as a resettlement site for urban poor families requiring relocation;

WHEREAS, in a letter dated April 16, 2013, the MUNICIPALITY requested the NHA for assistance for the development of the municipal-owned lot located in Brgy. Poblacion, Mina, Iloilo as a resettlement site, hereinafter referred to as Annex “B” and made an integral part hereto.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE HON. REY P. GRABATO, MUNICIPAL MAYOR, MINA, ILOILO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL HOUSING AUTHORITY (NHA) REPRESENTED BY ITS GENERAL MANAGER, ATTY. SINFOROSO R. PAGUNSAN WITH OFFICE ADDRESS AT NHA BUILDING, ELLIPTICAL ROAD, DILIMAN, QUEZON CITY FOR THE IMPLEMENTATION OF THE RESETTLEMENT ASSISTANCE PROGRAM FOR THE MUNICIPALITY OF MINA.**
