**WHEREAS**, that at about 3:40 o'clock in the afternoon of June 19, 2016, the aforementioned team left station to response the call of PB Gemma Perdosa of Brgy., Bangac, Mina, Iloilo;

**WHEREAS**, on same afternoon the responding teams assisted by said PB personally saw Edgar Esteva y Pangantihon, of legal age, single and a resident of same place causing alarm and scandal in the area. Subject was arrested by the PNP team and body searched was conducted and recovered from his control and possessions are the following items to wit: one (1) wallet shape fish, color black and red combination marked as "EPE 1" containing two (2) heat sealed transparent sachet allegedly with white crystalline substance of shabu marked as EPE 2, EPE 3, EPE 4 and EPE 5. Subject was informed of right under the Miranda Doctrine and presently at Mina Police Station for safekeeping and proper disposition;

**WHEREAS**, recovered items were properly marked, inventory and photograph in the presence of Brgy. Official for Laboratory Examination at PRO6 Crime Laboratory, Camp Delgado, Iloilo City. Case for violation of RA 9165 known as "Comprehensive Dangerous Drug Act of 2002" was filed before the Sala of Hon. Dodie Balume, Asst., Provincial Prosecutor docked under License No. VI-II, INQ – 16F – 00889 to 0899 – A respectively.
