RESOLUTION TO RETAIN THE MUNICIPAL MAYOR OF MINA, ILOILO, HON. REY P. GRABATO, AS THE AUTHORIZED SIGNATORY TO THE MEMORANDUM OF AGREEMENT (MOA) WITH THE LAND BANK OF THE PHILIPPINES (LBP)-JARO BRANCH, ILOILO CITY FOR LGU'S AVAILMENT OF LIVELIHOOD LOAN FOR ITS OFFICIALS AND EMPLOYEES

WHEREAS, the Municipality of Mina is presently availing of a livelihood loan extended by the LBP-Jaro Branch, Iloilo City which is governed by a MOA executed by the previous administration represented by Mayor Rey P. Grabato as per Resolution No. 2013-059;
