APPROPRIATION ORDINANCE NO.2016 - 001

**AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 01, SERIES OF 2016,
FOR THE GENERAL FUND OF THE MUNICIPALITY OF MINA, PROVINCE OF
ILOILO AMOUNTING TO ONE MILLION SEVEN HUNDRED FIFTY THOUSAND
PESOS (P1,750,000.00)**

WHEREAS, as per Local Budget Form No. 161-A, the OIC-Municipal Treasurer and the ICO-Municipal Accountant has certified the availability of the amount of Three Million Pesos (P3,000,000.00) for appropriation;

WHEREAS, the said amount was taken from the new revenue sources as reflected in the above-stated form hereto attached;

WHEREAS, this supplemental budget is intended to finance various programs, projects activities and services for Fiscal Year 2016 as enumerated in the herein attached LBP Form No. 161 amounting to One Million Seven hundred Fifty Thousand Pesos (P1,750,000.00) with remaining unappropriated balance of One Million Two Hundred Fifty Thousand Pesos (P1,250,000.00).

NOW, THEREFORE:

BE IT ENACTED by the Sangguniang Bayan of Mina, Province of Iloilo in session assembled that:

Section 1. The amount of Three Million Pesos (P3,000,000.00) under the Local Budget Preparation Form No. 161-A is hereby appropriated to fund Supplemental Budget No.01, series of 2016, as follows:

- a.) P 1, 750,000.00 to finance various PPAs and services 2016
- b.) P 1, 250,000.00 - Unappropriated Balance
P 3, 000,000.00- TOTAL

Section 2. Statement of Supplemental Appropriations for Supplemental Budget are actually available as contained in the Local Budget Form No 161-A hereto attached as "Annex A" of this Ordinance is hereby approved.

Section 3. This Ordinance shall take effect upon approval.
