**APPROPRIATION ORDINANCE NO. 2016 - 002**

**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF GENERAL FUND AND SUPPLEMENTAL BUDGET NO. 1 OF ECONOMIC ENTERPRISE WITH A TOTAL AMOUNT OF ONE MILLION SIX HUNDRED FORTY FOUR THOUSAND THIRTY SIX PESOS (P1,644,036.00) FOR THE GRANT OF MID-YEAR BONUS EQUIVALENT TO ONE-MONTH BASIC SALARY AS AN ADDITIONAL BENEFIT TO ALL MUNICIPAL OFFICIALS AND EMPLOYEES IN THE MUNICIPALITY OF MINA**

**WHEREAS**, Budget Circular No. 2016 - 4 dated April 28, 2016 authorizes the release of Mid-Year Bonus to all municipal officials and employees;

**WHEREAS**, the amount of Mid-Year Bonus authorized by this Sanggunian for each officials and employees shall be equivalent to one-month basic salary;

**WHEREAS**, there is an available amount of **ONE MILLION SIX HUNDRED FORTY FOUR THOUSAND THIRTY SIX PESOS (P1,644,036.00)** from the 2015 Surplus and 2016 Savings of vacant positions for the grant of Mid-Year Bonus to all Municipal Officials and Employees of LGU-Mina

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo in session assembled that:

**Section 1.** The amount of **ONE MILLION SIX HUNDRED FORTY FOUR THOUSAND THIRTY SIX PESOS (P1,644,036.00)** is hereby appropriated to fund the Supplemental Budget No.2 of General Fund and Supplemental Budget No. 1 of Economic Enterprise, Series of 2016 to grant the Mid-Year Bonus of the Municipal Officials and Employees of the Municipality of Mina, as follows:

a.) General Fund -----	P1,305,446.00
b.) Economic Enterprise -----	<u>P 338,590.00</u>
TOTAL	<u>P 1,644,036.00</u>

**Section 2.** Statement of Funding Sources and Statement of Supplemental Appropriations for Supplemental Budget are actually available as contained in the Local Budget Form No. 9 and 10 hereto attached as Annexes A and B of this Ordinance is hereby approved.

**Section 3.** This Ordinance shall take effect upon approval.
