RESOLUTION NO. 2015- 004

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. REY P. GRABATO, TO ENTER INTO AND SIGN IN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE IMPLEMENTATION OF BARANGAY FACILITIES UNDER THE RECOVERY ASSISTANCE TO YOLANDA (RAY) – DILG FUND

WHEREAS, to facilitate the return to normalcy of local government services and economic activities in the Yolanda-affected areas, the Department of the Interior and Local Government (DILG) established the Recovery Assistance on Yolanda (RAY) – DILG Fund which aims to reconstruct and rehabilitate/repair LGU administrative buildings, public markets, civic centers and barangay facilities with build back better (BBB) design considerations to make them more disaster-resilient public infrastructure;

WHEREAS, the RAY-DILG Fund covers 171 cities/municipalities including their respective barangays, within the 50 km. radius typhoon path, identified by the Department of Science and Technology (DOST) as most affected by Typhoon Yolanda;

WHEREAS, this City/Municipality, being one of the 171 most affected LGUs has been identified as a recipient of RAY-DILG Fund;

WHEREAS, this Province/City/Municipality has submitted/endorsed the Program of Works (POWs) for the following damaged barangay facilities (referred herein as Subprojects):

Now, therefore, upon motion of Hon. _____ duly seconded by Hon. _____, this Sangguniang Bayan do hereby resolved to:

1. Affirm the interest of the Municipality of Mina to avail of the RAY-DILG Fund for the identified Subproject/s as listed above;
2. Authorize Hon. Rey P. Grabato or his, successor, for and on behalf of the Municipality of Mina to enter into and sign in an agreement with the DILG and to enter into contract for any procurement of goods/services/infrastructure during Subproject implementation;

RESOLVED FURTHERMORE, this Municipality commits to:

1. Utilize the RAY-DILG, Fund exclusively for the Subproject/s in accordance with the approved Program of Works (POWs);

2. Designate a Subproject Manager to supervise and oversee the implementation of the Subproject as well as act of focal person of the LGU;
3. Provide counterpart funds for the (i) administrative and operational costs for Subprojects implementation, i. e. office supplies, travel expenses, communication, meetings and consultations, salaries, construction supervision, and the likes (ii) excess cost due to variation orders including any unforeseen work items as may not be covered by the RAY-DILG Fund (iii) operations and maintenance of the completed facilities/structures;
4. Execute the implementation of the Subproject/s with due diligence and efficiency in conformity with sound administrative, financial, environmental and engineering practices;
5. Abide by the standards and policies of the National Government related to the design and implementation of the Subproject/s;
6. Ensure that the beneficiary barangays are properly involved in the planning and implementation of the Subproject/s;
7. Promote transparency and accountability in the utilization of funds by ensuring that the project billboards are installed and project status and updates are submitted to the DILG in accordance with the formats as maybe prescribed, and allowing the civil society organizations and the barangay folks to secure any information at anytime during the implementation of the Subprojects;
8. Comply with requirements, policies, and LGU responsibilities as set forth in the Memorandum of Agreement with the DILG.

RESOLVED FINALLY, to furnish the Department of the Interior and Local Government (DILG) with a copy of this Resolution.
