RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, MINA, ILOILO TO ENTER AND SIGN INTO A CONTRACT OF SERVICES WITH MRS. FELI A. SUSTENTO, OF LEGAL AGE, MARRIED AND A RESIDENT OF BRGY. MINA WEST, MINA, ILOILO AS CONTRACT WORKER IN BALAY PAGLAUM/CRISIS CENTER FOR WOMEN AND CHILDREN

WHEREAS, the Local Government Unit of Mina has established a Crisis Center for abused women and children who are in conflict with the law and to cater those other social problems besetting our society;

WHEREAS, the LGU of Mina is in need of a well versed, expert, experienced and competent manager in terms of effective solving and pacifying social problems involving women and children within and outside this locality;

WHEREAS, although Mina has qualified social worker, but experience wise, they still lack competency and expertise in terms of solving very complicated cases as expected;

WHEREAS, Mrs. Feli Assin Sustento is an expert, well versed and competent social worker who expressed willingness to serve and share her knowledge with this municipality as a **contract worker** and or **project development manager** for the affected women and children specifically at the Balay Pag-laum, and for other purposes;

WHEREAS, a **contract of services** to this effect is needed between the two (2) parties, the LGU and the Contract Worker, for their signatures, hence this authority.

NOW, THEREFORE:
