**RESOLUTION CONFIRMING EXECUTIVE ORDER NO. 006, SERIES OF 2015
ISSUED BY MAYOR REY P. GRABATO, MINA, ILOILO, RE: UPDATING OF
COMPREHENSIVE LAND USE PLAN (CLUP) 2010-2020 TO INCLUDE DISASTER
RISK REDUCTION AND CLIMATE CHANGE ADAPTATION MEASURES IN
ACCORDANCE WITH THE HLURB SUPPLEMENTAL GUIDELINES**

WHEREAS, the municipality's CLUP was found to be substantial and has complied with the requirements in accordance with the guidelines for CLUP formulation, however, it did not include Disaster Risk Reduction and Climate Change Adaptation measures due to the absence of necessary guidelines pertaining thereto;

WHEREAS, due to the rise of environmental catastrophe being experienced brought about by climate change, the HUDCC-HLURB issued supplemental guidelines on mainstreaming climate change and disaster risks in the CLUP to reduce disaster and climate change risks;

WHEREAS, coincidentally, Mina is one among the pilot LGUs identified by the ASEAN in its adopt-a-municipality program for Resident Recovery Project extending technical assistant for the updating of CLUP;

WHEREAS, in view of the aforementioned and upon thorough deliberations the Sanggunian finds very important to confirm Executive Order No. 006, series of 2015, thus this confirmation.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION CONFIRMING EXECUTIVE ORDER NO. 006, SERIES OF 2015 ISSUED BY MAYOR REY P. GRABATO, MINA, ILOILO, RE: UPDATING OF COMPREHENSIVE LAND USE PLAN (CLUP) 2010-2020 TO INCLUDE DISASTER RISK REDUCTION AND CLIMATE CHANGE ADAPTATION MEASURES IN ACCORDANCE WITH THE HLURB SUPPLEMENTAL GUIDELINES.**
