MILWIDA GUEVARA FOR THE IMPLEMENTATION OF USAID SUB-PROJECT IN ALL PUBLIC ELEMENTARY SCHOOLS OF THE MUNICIPALITY OF MINA

WHEREAS, Synergeia Foundation is the lead Implementing Partners for the implementation of the USAID-funded and sub-project entitled Hugpong sa Pagbangon under the Education Governance Effectiveness (EDGE) Program;

WHEREAS, Hugpong sa Pagbangon aims to provide the needed assistance to public elementary schools, teachers and pupils affected by Typhoon Yolanda in selected municipalities in the visayas and to provide Community Incentive Grants (CIG), among others, to support the needs of Yolanda-affected schools as articulated in proposals submitted through and endorsed by the local school board;

WHEREAS, both parties and all others concerned are covenants to perform and comply with the terms and conditions stipulated in the Memorandum of Agreement;

WHEREAS, an authority to sign in the agreement by the Municipal Mayor from the Sanggunian is a necessity pursuant to the provision of the RA 7160, hence this resolution.
