MACAPOBRE, REGIONAL DIRECTOR, DSWD REGIONAL OFFICE VI, ILOILO CITY FOR THE IMPLEMENTATION OF THEIR RESPECTIVE PRIORITIZED SUB-PROJECTS DULY APPROVED BY THE MUNICIPAL FORUM RESOLUTION NO. 14-001 DATED NOVEMBER 26, 2014

WHEREAS, presented for consideration is the authority to sign by the Municipal Mayor in the Tripartite agreement executed between the LGU of Mina, the 19 barangays above-stated and the DSWD Regional Office VI for the community-managed implementation of their respective priority sub-projects under the KC-NCDDP;
