**RESOLUTION NO. 2015-032**

**RESOLUTION ADOPTING SP RESOLUTION NO. 2014-263, PROVINCE OF ILOILO, EMBODYING PROVINCIAL ORDINANCE NO. 2014-112, SERIES OF 2014, “AN ORDINANCE ON THE STANDARDIZED UTILIZATION OF PHILHEALTH INSURANCE CORPORATION (PHIC) MATERNITY CARE PACKAGE (MCP) AND NEW BORN PACKAGE BENEFITS IN THE RURAL HEALTH UNITS OF ILOILO PROVINCE”**

WHEREAS, Provincial Ordinance No. 2014-112 was enacted consistent with the provisions of Article II, Section 15 of the 1987 Philippine Constitution and Article XIII Section 11 thereof;

WHEREAS, the Department of Health has formulated the Maternal Newborn and Child Health Nutrition Strategy under Administrative Order 2008-009, Implementing the Health Reforms to rapidly reduce Maternal Maternity Ratio and Neonatal Maternity in response to achieving Millenium Development Goal No. 5-The Reduction of Maternal Mortality Ratio by 2/3 by the Year 2015;

WHEREAS, to sustain the operation and implementation of Maternal and Child Health Services like the provision of quality prenatal and postpartum care attendance, facility-based deliveries, and health attended by skilled health workers including professional fees, the Philippine Health Insurance Corporation (PHIC) offers Maternity Care Package and Newborn Care Package to all accredited health facilities;

WHEREAS, pursuant to Philippine Health Insurance Corporation (PHIC) Circular 011-2011, the payment for claims for Maternity Care Package (MCP) is Eight Thousand Pesos (P 8,000.00) and Newborn Care Package is One Thousand Seven Hundred Fifty Pesos (P 1,750.00) in all accredited non-hospital facility;

WHEREAS, Department of Health Administrative Order 187 Series of 2004 dated November 30, 2004 provides that fees paid for professional fees rendered by salaries public providers shall be allowed to be retained by the health facility in which services are rendered and be pooled and distributed among health personnel;

WHEREAS, the Provincial Government of Iloilo needs to enact an ordinance that would standardize the utilization of Philippine Health Insurance Corporation (PHIC) Maternal Care Package (MCP) benefit and Newborn Care Package (NCP) benefit in all Rural Health Units to sustain its operation.

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION ADOPTING SP RESOLUTION NO. 2014-263, PROVINCE OF ILOILO, EMBODYING PROVINCIAL ORDINANCE NO. 2014-112, SERIES OF 2014, “AN ORDINANCE ON THE STANDARDIZED UTILIZATION OF PHILHEALTH INSURANCE CORPORATION (PHIC) MATERNITY CARE PACKAGE (MCP) AND NEW BORN PACKAGE BENEFITS IN THE RURAL HEALTH UNITS OF ILOILO PROVINCE”**.
