RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF UNDERSTANDING WITH THE GRANDT PLANNERS, INC. (GPI) WITH PRINCIPAL OFFICE AT UNIT 402 AMAREMCA BLDG., 107-A, KALAYAAN AVENUE, BARANGAY CENTRAL, QUEZON CITY, REPRESENTED BY ITS PRESIDENT GRACE C. RAMOS FOR THE UPDATING OF COMPREHENSIVE LAND USE PLAN (CLUP) OF THE MUNICIPALITY OF MINA

WHEREAS, presented for consideration is the authority to sign by the Municipal Mayor in the Memorandum of Understanding (MOU) with the GPI for the updating of the municipality's CLUP for CY 2010-2020;

WHEREAS, the Association of Southeast Asian Nations (ASEAN), through the Assistance for the Recovery of Yolanda-affected Areas (ARYA) Project Steering Committee, seeks to extend Strategic Assistance for the Recovery and Rehabilitation of the areas affected by typhoon Yolanda in the Philippines, which identified the Municipality of Mina as one of the pilot LGUs affected by typhoon Yolanda;

WHEREAS, the ASEAN, through a Special Services Agreement, commissioned GPI as the Consultant for the project, re: CLUP updating to integrate disaster resilience principles in the plan;

WHEREAS, an authority to sign in the MOU from the Sanggunian is needed pursuant to the provisions of RA 7160.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
