RESOLUTION No. 2015 - 036

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER AND SIGN INTO AN AGREEMENT WITH OTHER MUNICIPALITIES FOR THE CLUSTER ON SOLID WASTE MANAGEMENT

WHEREAS, the establishment, operation and maintenance of sanitary landfill at the Municipality of Janiuay requires a sizable amount due to technical and environmental requirements and criteria to be met;

WHEREAS, the massive financial requirements to establish, operate and maintain a sanitary landfill may not be affordable for individual municipality particularly those belonging to lower class;

WHEREAS, Section 33 of RA 7160, otherwise known as the Local Government Code of 1991, allows local government units through memoranda of agreement to consolidate their efforts, services and resources for the purpose commonly beneficial to them;

WHEREAS, Section 44 of RA 9003 mandates local government units to coordinate their efforts, services and resources to jointly address common solid waste management problems by establishing common waste disposal facilities;

WHEREAS, there exists a site identified and approved by the DENR Environmental Management Bureau at the Municipality of Janiuay appropriate enough for the establishment of a sanitary landfill;

WHEREAS, the parties hereto composed of municipalities in the Iloilo 3rd Congressional District and affiliate municipalities of Badiangan, Calinog, Bingawan, Cabatuan, Maasin, Mina, Pototan and Lambunao agreed to form themselves into a CLUSTER for the establishment of a common disposal facility subject to the terms and conditions acceptable to them.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER AND SIGN INTO AN AGREEMENT WITH OTHER MUNICIPALITIES FOR THE CLUSTER ON SOLID WASTE MANAGEMENT.
