**RESOLUTION NO. 2015-040**

**RESOLUTION EXTENDING COMMENDATION TO THE MINA PNP HEADED BY  
PINSP ROY DIAZ CASTRO FOR THE APPREHENSION OF TWO (2) ILLEGAL  
DRUG PERSONALITIES IN THE PERSONS OF GOMER NOGRALES Y JERESA  
AND IAN DAVE LIBALIB Y LIRA DURING THE BUY BUST OPERATION AT  
BARANGAY AGMANAPHAO, MINA, ILOILO**

WHEREAS, at about 12:50 in the morning of March 20, 2015 Team lead by PO3 Aaron G. Gaton, PO2 Ricky Leal, PO1 Andy Datiles, PO1 Glenn Pimentel under the supervision of PINSP Roy Diaz Castro, PNP OIC, COP of Mina Police Station, Mina, Iloilo, arrested at Barangay Agmanaphao, Mina, Iloilo, the person of Gomer Nograles y Jereza, 45 yrs. Old, married and Ian Dave Libalib y Lira both resident of same place, confiscated from the control and possession of Gomer Nograles were two (2) pieces of heated sealed transparent plastic sachet containing white crystalline substance of suspected shabu from his pocket, one (1) suspected shabu inside his brown wallet, two (2) empty plastic from his pocket, Four (4) pieces of cutted aluminum foil, one (1) piece of five hundred (500) peso bill, as marked money with SN 194797974, Two (2) pieces five hundred (500) peso bills, one (1) white cherry mobile cell phone, color white with simcard, one Brown wallet, one black ryban, items has various distinguishing markings for ready and easy identification by the custodian;

WHEREAS, recovered from Ian Dave Libalib y Lira were cash amount of Seventy Three pieces (73) of One Thousand (1,000) peso bills, and other various peso bills with total amount of Seventy Five thousand six hundred forty five (P75, 000,645.00) pesos Philippine currency, one (1) unit 45 caliber pistol colt MARK IV SN 351841 with one magazine, three (3) live ammos. One (1) extra magazine, one (1) Samsung cell phone. Upon apprehension operatives informed the suspect of their constitutional rights under the Miranda Doctrine Inventory of the confiscated items was conducted in the presence of Punong Barangay Ciriaco Perocho Sr., and Kagawad Susan Bolivar of same barangay and brought to police station for safekeeping and disposition. Exhibit will be submitted to PNP Crime Laboratory PRO 6 for examination while suspect are presently under the custody of the Police Pending filing of formal complaint;

WHEREAS, in view of the above-stated considerations and to give credit to their excellent performance, the Mina PNP concerned deserves a commendation.
