**RESOLUTION EXTENDING COMMENDATION TO THE MINA PNP HEADED BY
PINSP ROY DIAZ CASTRO FOR THE ARREST OF ROMEO SOMEJO Y PROCALLA
AND IDNOR CORDERO Y PALMA FOR ILLEGAL LOGGING WHICH IS IN
VIOLATION OF PD 705 ALSO KNOWN AS FORESTRY REFORM CODE OF THE
PHILIPPINES**

WHEREAS, last March 21, 2015, at about 8:30 o'clock in the evening, the team led by PINSP Roy Diaz Castro, OIC, on their mobile patrol conducted, were able to intercept truck loaded with timber of various size without the corresponding permits and other supporting documents showing the legality to transport out to other municipalities of which is in violation of PD 705 or the Forestry Reform Code of the Philippines;

WHEREAS, this situation lead to the confiscation of the timber and the arrest of Romeo Somejo y Procalla, 44 years old, driver of the Fuso Canter, married and a resident of Brgy. Ayuyan, Passis City, and Idnor Cordero y Palma, timber owner, 27 years old, married and a resident of Brgy. Nasirum, Mina, Iloilo. Complete details can be seen on the Mina PNP Police blotter dated March 21, 2015 hereto attached;

WHEREAS, in view of such excellent performance, the Mina PNP led by PINSP Roy Diaz Castro, deserves a commendation, hence this resolution.

NOW, THEREFORE:
