**RESOLUTION EXTENDING COMMENDATION TO MINA PNP STATION
POLICE OFFICER, CHIEF INTEL PO3 AARON GATON, PO1 ANDY DATILES UNDER
THE SUPERVISION OF OIC COP, PINSP ROY DIAZ CASTRO, FOR A SUCCESSFUL
ACCOMPLISHMENT AGAINST VIOLATION OF RA 9165 OR COMPREHENSIVE
DANGEROUS DRUG ACT OF 2002**

WHEREAS, that on or about 3:30 o'clock in the afternoon of May 8, 2015, intelligence operatives of Mina PNP Station led by PO3 Aaron Gaton, PO1 Andy Datiles under the supervision of PINSP Roy Diaz Castro, OIC dispatch with confidential agent (CA) to conduct buy bust operation against Randolph Sungcuya y Bero "alias White" of legal age, married of Badiangan, Mina, Iloilo presently residing at Brgy. Amiroy, same municipality; brought along with them, one (1) piece five hundred (500.00) peso bills Philippine Currency with serial number REG41385 (marked money) to confirm the alleged involvement of subject on illegal drug trade activities on prohibited drugs methamphetamine hydro lore or shabu;

WHEREAS, at about 4:30 p.m. of same date the aforesaid Intel officer and the responding team returned station after conducting buy bust operation against the alleged suspect with positive result as the consequence of this campaign;

WHEREAS, the team was able to arrest suspect after poseur-buyer/Police Officer with the assistance of a confidential agent conducted a deal with the suspect in the amount of five hundred (500) peso in exchange for one (1) pc. heat-sealed transparent plastic sachet containing crystalline substance/shabu;

WHEREAS, upon his arrest several items were confiscated including various illegal drugs paraphernalia, cellphone, motorcycle with plate no. 062008 as witnessed by Punong Barangay, Gloria Alegado and Brgy. Kagawad Rio Casquero of Brgy. Amiroy;

WHEREAS, the suspect is now under custody of the PNP and evidence against him is being held at the Mina Police Station for safekeeping and disposition.

WHEREAS, this successful accomplishment is a clear signal part of their plan and program in accomplishing their performance Governance System in relation to PNP portal plan 2030, hence they deserved a commendation. Congratulations and carry on the good work.
