WHEREAS, in 1992 Local Election, Francisco Boy Alfaras was one of the candidate for barangay Kagawad and successfully place No. 1 under the leadership of the late Hon. PB Leonardo Prieto. WHEREAS, in 2010 election he returned for the second time as barangay kagawad and won the race. His services ended until his death on May 6, 2015. Francis Boy Alfaras was one of our distinguished kasimanwa that in his days of services both in public and private life he had served the Municipality particularly barangay Abat constituents with dignity, dedication, integrity and high sense of diligence;

WHEREAS, this manly bearing, the constituents demeanor and the upright life of our lamented brother so won our respect and affection that we regard his death not only a lost to his family but to our community as well;

WHEREAS, these words to pay tribute to him as a public servants, he was a worthy and loving husband and father beloved by his family, love and appreciated for his real worth. His lost shall be mourned by those nearest to him and these have the sincere and warm sympathy of the entire town people.
