RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPALITY OF MINA WITH DSWD REGION VI. ILOILO CITY REPRESENTED BY ITS REGIONAL DIRECTOR MA. EVELYN B. MACAPOBRE WITH OFFICE AT M.H. DEL PILAR ST., MOLO, ILOILO CITY FOR THE IMPLEMENTATION OF EMERGENCY SHELTER ASSISTANCE FUND

WHEREAS, presented for consideration is the authority to sign by the Municipal Mayor in the Memorandum of Agreement (MOA) with the DSWD Regional Director for the implementation of Emergency Shelter Assistance Fund in the Municipality of Mina;

WHEREAS, the DSWD Regional Field Office is mandated to implement programs and services along disaster related; recognizes and appreciates the effort and participation of the LGUs in responding to the needs of the disaster victims; and willing to provide technical assistance to LGUs to be its conduit in the provision of basic services and implementation of its programs in the pursuit of attaining its mandate;

WHEREAS, the Municipality of Mina is mandated to provide financial and material support to the disaster victims;

WHEREAS, the Municipality of Mina, in its willingness to expand their programs and services for the disaster victims was able to request and avail of financial assistance from the DSWD Region VI for typhoon Yolanda victim amounting to Two Million Nine Hundred Forty Thousand Pesos (P2,940,000.00);

WHEREAS, a Memorandum of Agreement to this effect is very necessary pursuant to R.A 7160.

NOW, THEREFORE:
