RESOLUTION EXTENDING COMMENDATION TO MINA PNP STATION LED BY INTEL OFFICER, PO3 AARON GATON TOGETHER WITH PO1 ANDY DATILES UNDER THE SUPERVISION OF PINSP ROY DIAZ CASTRO, OFFICER IN-CHARGE, IN A SUCCESSFUL OPERATION ON THE AFTERNOON OF MAY 21, 2015 AT BARANGAY CABALABAGUAN, MINA, ILOILO, PHILIPPINES

WHEREAS, that at or about 4:00 o'clock in the afternoon of May 21, 2015 Intel operatives of Mina Police Station led by PO3 Aaron Gatton together with PO1 Andy Datiles under the supervision of PINSP ROY DIAZ CASTRO, Officer In-Charge, left station with confidential agent (CA) to conduct a buy bust operation against violators of RA 9165 "known as Comprehensive Dangerous Drug Act of 2002";

WHEREAS, at about 5:45 in the afternoon of same date Police Team returned station together with the person of Alexander Patriarca y Ding-ding , who was apprehended during a buy bust operation at the aforesaid Barangay;

WHEREAS, recovered from his control and possession are as follows: four (4) sachet of suspected shabu, eight (8) pieces cut aluminum foil, one (1) piece lighter color blue, one (1) Nokia cell phone color black, One (1) piece Two Hundred (P200.00) peso bill with Serial No. JL584596, one (1) hundred peso bill bearing serial no. FA422755 and other various denominations serving as (marked money) and drugs paraphernalia;

WHEREAS, upon apprehension subject was properly informed of the nature of the offense committed and apprised of his rights within the framework of our constitution as exercise under the Miranda Doctrine. Subsequently, inventory was made at the scene of the crime witnessed by Marlene Pelaez and Ofelio Pedrajas Punong Barangay and Kagawad of Cabalabaguan this municipality respectively. Suspect and recovered items are under the custody of Mina Police Station for safekeeping and proper disposition;

WHEREAS, case of violation of RA 9165, known as Comprehensive Dangerous Drug Act of 2002 was filed before the office of Hon. Susanita G. Orleans, Assistant Provincial Prosecutor, City of Iloilo on May 23, 2015, docketed under I.S. no. VI-II-INQ-15E-00387 to 00387-A and suspect presently under the custody of MPS, Mina, Iloilo;

WHEREAS, this meritorious and exemplary job well done in the campaign against all forms of criminalities, the Municipal Officials, employees and the residents of Mina, Iloilo highly appreciated such performance and worthy of commendation. Carry on the good work and congratulations.
