RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE No. VI, REPRESENTED BY ITS REGIONAL DIRECTOR, PONCIANO M. LIGUTOM FOR THE IMPLEMENTATION OF CASH FOR WORK UNDER THE TUPAD PROGRAM OF THE DOLE

WHEREAS, presented for consideration to the August Body is the Authority of Mayor Rey P. Grabato to enter into a Memorandum of Agreement (MOA) with REGIONAL Director Ponciano M. Ligutom, as regard to the implementation of cash for work **TUPAD** Program;

WHEREAS, the DOLE is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE provides assistance to help displaced or “to be” displaced workers and the unemployed poor in coping with the closure or slowing down of operations of companies as a result of economic disruptions and/or the occurrence natural disasters, calamities, that affect their economic base under its **TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS PROGRAM**, pursuant to the provisions of DO No. 137-14, series of 2014;

WHEREAS, the DOLE-RO No. VI has been given the responsibility to implement Short-term Employment under TUPAD Program to enable the displaced workers to engage in short-term community works to provide them with temporary wage employment for a period of 15 days and shall implement the foregoing Project in Municipality of Mina, Province of Iloilo in partnership as accredited co-partner;

WHEREAS, the project identified to this effect is the rehabilitation of the Montogawe Eco Park once wrecked by typhoon Frank and Yolanda;

WHEREAS, R.A. 7160 otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor may represent the Municipality and sign in its behalf in contracts, obligations and other documents upon authorization by the Sangguniang Bayan, hence this Resolution.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT REGIONAL OFFICE No. VI, REPRESENTED BY ITS REGIONAL DIRECTOR, PONCIANO M. LIGUTOM, FOR THE IMPLEMENTATION OF CASH FOR WORK UNDER THE TUPAD PROGRAM OF THE DOLE.**
