GRABATO, TO SIGN IN THE AGREEMENT WITH DEUTSCHE GESELLSCHAFT FUR INTERNATIONALE ZUSAMMENARBEIT (GIZ) REPRESENTED BY ITS PROGRAM MANAGER MAX JOHANNES BAUMANN, WITH OFFICE ADDRESS AT 2ND FLOOR PDCP BUILDING, V.A. RUFINO ST., COR. L.P. LEVISTE ST., SALCEDO VILLAGE, MAKATI CITY, GOVERNING THE GRANTING OF LOCAL SUBSIDY FROM THE GIZ FUNDS

WHEREAS, the LGU of Mina is availing of subsidy from the GIZ Project funds as part of the constructions of the Federal Republic of Germany, to enhance local extension system through capacitating the agricultural extension workers and farmer leaders to help farmers in increasing yield and income;

WHEREAS, with the proposed project in partnership with the GIZ Philippines, the LGU can now boost agriculture extension especially in rice production and marketing;

WHEREAS, this proposed project aims to contribute to the enhancement of farmers' market position in the rice value chain, as well as their farm yield and income through better extension education and better market linkage;

WHEREAS, an agreement to this effect is very necessary pursuant to R.A 7160.
