RESOLUTION NO. 2015 - 063

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO AUGMENT PERSONAL SAVINGS (PS) TOTAL AMOUNT OF ONE MILLION FIVE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED FIFTEEN PESOS (P1,524,915.00) FOR THE PAYMENT OF PRODUCTIVITY ENHANCEMENT INCENTIVES (PEI) OF OFFICIALS AND EMPLOYEES, EQUIVALENT TO ONE (1) MONTH BASIC SALARY

WHEREAS, Executive Order No. 181 issued by the President of the Philippines dated May 15, 2015 provides for implementation of the provisions of the FY 2015 General Appropriation Act (GAA) on the grant of the FY 2015 Productivity Enhancement Incentives (PEI) to government employees;

WHEREAS, Item (4)(a)(iv) of the Senate and House of Representative Joint Resolution (JR) No. 4 (s 2009) includes *incentives* as a component of the Total Compensation Framework for government personnel. Items 4 (h)(ii) thereof also provides for the grant of *incentives* as rewards for exceeding agency financial and operational performance targets, and to motivate employees efforts toward higher productivity;

WHEREAS, Pursuant to Section 1(d) local government units are authorized to grant PEI for FY 2015 equivalent to P5,000.00 or one month basic salary as of May 31, 2015 to their respective qualified personnel and consistent with the conditions under Sections 2(a), 4(d)(1), 6(1 & 2)(a)(b), 7(a-d), 9(d) and 10;

WHEREAS, the LGU of Mina has satisfactorily complied with the requirements under the Good Financial Housekeeping (formerly Seal of Good Housekeeping) consistent with DILG Memorandum Circular No. 2014-39, re: FY 2014 Seal of Good Local Governance as certified by DILG Undersecretary Austere A. Panadero, and a hall famer on Tax Record Management;

WHEREAS, the LGU of Mina has available PS savings of P1,524,915.00 to provide this purpose, thus this authorization.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO AUGMENT PERSONAL SAVINGS (PS) TOTAL AMOUNT OF ONE MILLION FIVE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED FIFTEEN PESOS (P1,524,915.00) FOR THE PAYMENT OF PRODUCTIVITY ENHANCEMENT INCENTIVES (PEI) OF OFFICIALS AND EMPLOYEES, EQUIVALENT TO ONE (1) MONTH BASIC SALARY.**
