RESOLUTION EXTENDING COMMENDATION TO MINA PNP LED BY PI ROY DIAZ CASTRO, PNP OFFICER IN-CHARGE TOGETHER WITH PO3 AARON GATON, PO2 RICKY LEAL, PO1 ANDY DATILES AND PO1 FERDINAND ARMADA AND RESPONDING TEAM FOR A SUCCESSFUL OPERATION AGAINST VIOLATION OF R.A. 9165 KNOWN AS “COMPREHENSIVE DANGEROUS DRUG ACT OF 2002”

WHEREAS, that on about 11:00 o'clock in the morning of June 24, 2015 Intel operatives of Mina Police Station led by PO3 Aaron Gatton with PO2 Ricky Leal, Po1 Andy Datiles and PO1 Ferdinand Armada under the supervision of PI Roy Diaz Castro with confidential agent left station to conduct buy bust operation against subject Ryan Defensor. They were equipped with Two (2) pcs. One hundred (P100.00) pesos and two (2) pcs. fifty peso bills served as marked money;

WHEREAS, at about 12:10 o'clock in the afternoon the aforementioned operatives arrested by same officer and the responding team led by PI Roy Diaz Castro, PO3 John C. Brillo, PO3 Rommel Tabujara, PO2 Jhudan B. Pastrana and PO1 Frankline John C. Luzarita returned station from Brgy. Cabalabaguan of this Municipality together with the arrested person Ryan Anangan y Hechanova “alias Ryan Defensor”, 25 years old, single and a resident of Barangay Tolarucan, Janiuay, Iloilo. The operation was witnessed by Marlene Pelaez and Ofelio Pedrajas, Punong Barangay and Kagawad of Cabalabaguan, Mina, Iloilo respectively;

WHEREAS, items recovered from the control and possession of suspect are as follows: one (1) transparent plastic sachet containing white crystallize substance suspected “shabu” and containing Four (4) aluminum cutted rolled foil marked as RHA-1, one (1) unit Samsung cell phone color black and white combination marked as RHA-2, Two (2) pieces disposable lighter color green and black marked as RHA-3 and RHA-4, one (1) piece plain paper marked as RHA-5, Two (2) pieces One Hundred peso bill Philippines currency with serial number SP762032 and MV417777 (Marked Money) and Two (2) pieces Fifty peso bill with serial number BP765653 and BP765654 (Marked Money) and the driven motorcycle of the subject person described as one (1) Unit Honda CFT 125 motorcycle, color red, with plate no. 8689 SR. Immediately initial inventory on seized items was conducted thereat and was witnessed by Marlene Pelaez, Punong Barangay and Ofelio Pedrajas, brgy. Kagawad of Cabalabaguan, Mina, Iloilo and brought this station for proper disposition. Recovered items were in the possession of PO1 Andy Datiles for final inventory and submission to PNP Crime Laboratory 6 for examination while the arrested person was detained this lock-up cell of this police station prior subjected to drug test examination;

WHEREAS, the Local Government Unit of Mina granting the amount of Ten Thousand Pesos (P10,000.00) as a reward for every accomplishment in violation of R.A 9165 “known as Dangerous Drug Act of 2002”;

WHEREAS, this meritorious and exemplary job well done, the Municipal Officials and employees and the resident of Mina, Iloilo highly appreciated such performance and worthy of commendation. Carry on the good work and congratulations.
