RESOLUTION NO. 2015 - 072

RESOLUTION EXTENDING COMMENDATION TO MINA PNP STATION LED BY PINSP ROY DIAZ CASTRO, OIC-COP; MONTOGAWE EMERGENCY ASSISTANCE RESCUE TEAM HEADED BY THEIR PRESIDENT GIDEON ALUDIA; AND POTOTAN MOUNTAIN TIGERS HEADED BY ITS UNIT FELIPE P. GALINO, FOR SUCCESSFUL RETRIEVAL OPERATION OF DROWNED PERSON NAMED AS *JONEL BINAYAS Y GUINTIBANO* OF BRGY. AGMANAPHAO, MINA, ILOILO

WHEREAS, that on or about 8:30 p.m. of June 19, 2015, the Mina PNP Station received a telephone call from concerned citizen with the information that there was a drowning incident that happened at Brgy. Tumay, mina, Iloilo. Police team led by PINSP Roy Diaz Castro, SPO2 Jonathan Minaranda, PO3 Ramy Palorma, PO2 Carnel Bolivar, PO1 Elmer Sudario, PO1 Glenn Pimentel, PO1 Recie Marquez and PO1 Anthony Yap dispatched to the scene of incident and confirmed a positive report. They conduct investigation, search and rescue operation and due to time constrained and darkness the operation was temporarily postponed and returned early on the following day;

WHEREAS, victims was identified as Jonel Binayas y Guintibano, 20 years old, single and a resident of Brgy. Agmanaphao, Mina, Iloilo. Investigation showed that victim with his cousin John Paul Peñalosa y Alcasera, of legal age, single and a resident of Brgy. Tumay, this Municipality were on their way to Brgy. Lumbo, Pototan, Iloilo and while Jonel Binayas was crossing ahead on the river at Brgy. Tumay, he was carried away by a strong current of water that caused his instant missing;

WHEREAS, Mina MDRRMC Officer, Mr. Eden Pasuquin, MDRRMO-Designate, readily acted by organizing a composite search, rescue and retrieval team composed of Montogawe Emergency Assistance Rescue Team headed by their President Gideon Aludia, Pototan Mountain Tigers led by Unit Commander Felipe P. Galino and Full Force of Mina Police PNP Station led by OIC, COP PINSP Roy Diaz Castro.

NOW, THEREFORE:
