RESOLUTION NO. 2015 – 076

**RESOLUTION REQUESTING FOR THE RECLASSIFICATION OF THE
MUNICIPALITY OF MINA FROM FIFTH CLASS TO FOURTH CLASS MUNICIPALITY**

WHEREAS, the Bureau of Local Government Finance - Department of Finance (BLGF – DOF) has listed its top priorities for 2015 the ratification in Congress of the income reclassification bill and the conduct of performance standard evaluation of all municipal, city and provincial treasurer's across the country;

WHEREAS, as proposed, the evaluation processes shall cover two major aspects: the operational performance goal and competency performance goal. The first has 7 indicators that would allow the government agency, particularly the BLGF – DOF, to rate fiscal officers in various aspects of their job like revenue collection, revenue growth, and fund management or fiscal administration, and the second is to determine the individual capacity of the treasurers as public servants;

WHEREAS, the Municipality of Mina, had met all of these criteria as manifested by the increase on local revenue collections for the past 3 consecutive years, the proper resource/fund management or fiscal administration, and the exemplary performance of all municipal government workers as evident by various awards, like best performing LGU for local treasurers and assessors, the seal of good financial housekeeping awards being received by the municipality, and others;

WHEREAS, it is faithfully prayed that the proposed ratification of income reclassification bill being pushed by the BLGF, as the basis of their reclassification of all the provinces, cities and municipalities to be conducted, be ratified by Congress the soonest possible time;

WHEREAS, once ratified, this Sanggunian respectfully request to include the Municipality of Mina as one of the LGUs to be reclassified soon from its present status to next higher income class municipality to take effect in January, 2016 if possible, purposely to further improve the basic services for the general welfare of our constituency.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION REQUESTING FOR THE RECLASSIFICATION OF THE MUNICIPALITY OF MINA FROM FIFTH CLASS TO FOURTH CLASS MUNICIPALITY.**

Resolved further to forward copies of this resolution to the DILG Regional Office VI, through the Office of the Provincial Director, Province of Iloilo for indorsement; to the House of Representatives, Diliman Quezon City through the Honorable Congressman Arthur R. Defensor, Jr. of Iloilo 3rd Congressional District, for information and appropriate action; and to the BLGF – DOF Region VI, Iloilo City for their information and reference.
