RESOLUTION NO. 2015 - 078

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPALITY OF MINA WITH DSWD, REPRESENTED BY ITS REGIONAL DIRECTOR MA. EVELYN B. MACAPOBRE AND THE CIVIL SOCIETY ORGANIZATION (CSO) FOR THE IMPLEMENTATION OF BOTTOM-UP BUDGETING (BuB)

WHEREAS, the Human development and Poverty Reduction Cluster (HDPRC), the Good Governance and anti-Corruption Cluster (GGAC) and the Economic Development Cluster (EDC) organized under Executive Order No. 43, s. 2011, issued DBM-DILG-DSWD-NAPC Joint Memorandum Circular (JMC) No. 3, Series of 2012 to serve as the basis for the implementation of the Bottom-up Budgeting (BUB) for the FY 2015 budget preparation;

WHEREAS, the Bottom-up Budgeting which aims to make the planning and budgeting processes of both local and national government more participatory, by involving grassroots communities in the delivery of national services to poor communities be adapted by different National Agencies and Local Government Agencies as part of their poverty reduction effort;

WHEREAS, pursuant to the DBM, DILG, DSWD, and NAPC issued Joint Memorandum Circular 03 series of 2012 (JMC 03 s. 2012), specifying the guidelines for the implementation and monitoring of Bottom-up Budgeting projects for FY 2015, both the DSWD and Local Government Units and or CSOs shall uphold the principle of people empowerment event during the course of and post project implementation;

WHEREAS, a Memorandum of Agreement (MOA) to this effect shall be executed by the concerned parties for successful and effective implementation of the programs and projects under the BuB, specifically the Sustainable Livelihood Program amounting to Five Hundred Thousand Pesos (P500,000.00) under the DSWD;

WHEREAS, the terms and conditions are stipulated in the MOA which the concerned parties shall adhere with;

WHEREAS, an authority to sign by the Municipal Mayor from the Sanggunian pursuant to the provisions of RA 7160 is very necessary.

NOW, THEREFORE:

Be it resolved by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPALITY OF MINA WITH DSWD, REPRESENTED BY ITS REGIONAL DIRECTOR MA. EVELYN B. MACAPOBRE AND THE CIVIL SOCIETY ORGANIZATION (CSO) FOR THE IMPLEMENTATION OF BOTTOM-UP BUDGETING (BuB).**
