FEDERICO SIBAG PASOLOT, FORMER VETERANS ARMED FORCES OF THE
PHILIPPINES AND INP MEMBER**

WHEREAS, “From dust we come, to dust we shall return”..... After 92 years of a meaningful life, “Nong Peding or Tay Peding” was called by his Master to lay on his final rest. A good father to his five (5) daughters namely: Veronica, Violeta, Vina, Victoria and Vivian, four (4) sons namely: Federico, Jr., Floro, Fernando and Fermin, a loving husband to his wife, and a generous fellow to those who are needy;

WHEREAS, a man with principle and dedication to his family, friends and “kasimaryos” and was considered as one of the respected residents of his Barangay and for him being benevolent fellow;

WHEREAS, Federico Sibag Pasolot had served diligently the community as Rifleman in Armed Forces of the Philippines (AFP) in the year June 20, 1942 at the age of 14 years old, on February 13, 1943, he was one of the guerilla, of 39th P.C. Company Pototan, Iloilo from May 01, 1947 up to July 31, 1950, on August 01, 1950 up to September 16, 1953 he was enlisted as Philippine Army as Private 1st Class. This position had, been continuously effective from December 14, 1942 up to September 16, 1953. He was one of the “SHARPSHOOTER” participants in Japanese Forces Iloilo, Campaign against Moro Dissidents in Jolo, Sulu versus Huks Balahap in Panay Island and on May 04, 1956 he was one of the INP member here in Mina and Pototan and he retired on January 01, 1981. All those years of public service are years of dedication to the people he served, to his relatives and to his family;

WHEREAS, his body might be forgotten, but his deeds which made him and his family happy will be cherished forever until the end of time, and ultimately deserves enough of an outright honors.
