RESOLUTION EXTENDING COMMENDATION TO ELEMENTS OF MINA PNP STATION LED BY PO1 ANDY DATILES AND PO1 GABRIEL HEMBRA UNDER THE SUPERVISION OF PINSP ROY DIAZ CASTRO, OIC FOR A SUCCESSFUL OPERATION RE-CAMPAIGN AGAINST RA 9165 “OTHERWISE KNOWN AS COMPREHENSIVE DANGEROUS DRUG ACT OF 2003”

WHEREAS, that on or about 8:00 o’clock in the evening of September 2, 2015, Mina PNP Team led by PO1 Andy Datiles, PO1 Gabriel Hembra under the supervision of PINSP Roy D. Castro and CA (Confidential Agent) were dispatch to conduct a campaign on the existence of Illegal drugs in the municipality;

WHEREAS, that, at about 10:00 o’clock p.m. of same date the aforecited Police officer together with PO1 Ferdinand Armada and the responding team return station with arrested person named Rolen Pedrosa y Suyao, 22 yrs of age, single and a resident of Mina East, this municipality who was apprehended during the buy bust operation at Brgy. Tumay, Mina, Iloilo after poseur buyer Gabriel Hembra arranged a deal with mark money two (2) pcs. Fifty peso bill bearing serial number LUV956521 and M4 428537 and one (1) pc. Two (2) hundred pesos serial number PX848127 to the subject who in exchange suspect handed back to the poseur buyer one (1) pc heat sealed transparent plastic sachet a substance of shabu. Subsequently PNP Team witnessed by Punong Barangay Romulo Cartera and Richard Polines, Brgy. Kagawad of Tumay, same municipality conducted body search and taken from his control and possession two (2) transparent plastic sachet, suspected shabu marked as RSP-1 and RSP-2, one (1) pc. Disposable lighter marked as RSP-3 and marked money as herein mentioned and three (3) pcs. 20 peso bill with different serial number;

WHEREAS, Physical inventory was made at the scene of the crime witnessed by same Brgy. Officials, recovered items will be submitted to PRO6 crime laboratory for examination while suspect remained under the custody of Mina Police Station for safekeeping and proper disposition, investigator on case PO2 Ronnie Pradas Jr. Case for violation of RA 9165 Article 11, Section 5 and 11 in I.S. no. VI-11-ING-15I-00651 to 0065I-A was filed before the office of prosecutor, Myra A. Duremdes, Iloilo City on September 4, 2015 with. ***NO BAIL RECOMMENDED. THIS RESOLUTION GRANTED A CASH AWARD OF TEN THOUSAND PESOS (P10,000.00)*** from the Local Government Unit of Mina, Iloilo. Congratulations for the work well done. Carry on the good work.
