MACAPOBRE FOR THE IMPLEMENTATION OF CASH FOR BUILDING LIVELIHOOD ASSETS (CBLA) AMOUNTING TO FOUR MILLION THREE HUNDRED THIRTY TWO THOUSAND SEVEN HUNDRED TWENTY SEVEN AND 50/100 (4,332,727.50) UNDER THE SUSTAINABLE LIVELIHOOD PROJECT (SLP) OF THE DSWD IN THE MUNICIPALITY OF MINA
