RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER AND SIGN INTO A CONTRACT OF LABOR SERVICES WITH TEODORE P. MAGOS SR., PAKYAW CONTRACTOR, WITH ADDRESS AT BRGY. MINA WEST, MINA, ILOILO FOR THE CONSTRUCTION OF EVACUATION CENTER PHASE II

WHEREAS, presented for consideration is the authority to sign by the Municipal Mayor in the contract of labor services for the construction of evacuation center, phase 2, annexed to the municipal town hall;

WHEREAS, the construction of evacuation center phase 1 was financed by the municipality's award from the Seal of Good Housekeeping Award of the Department of Interior and Local Government (DILG) amounting to One Million Pesos (P1,000,000.00);

WHEREAS, the project remained unfinished due to insufficiency of the amount hence, the municipality has appropriated another amount of Two Million Pesos (P2,000,000.00) from the 20% development fund to complete the project and considering further that this project needs to hasten its completion to address the effect of natural calamity or disaster that may come anytime due to climate change;

WHEREAS, the project implementation shall be undertaken by way of administration in which the labor component shall be handled by the winning pakyaw contractor in the person of Teodore P. Magos, Sr.;

WHEREAS, an authority to sign in the contract of labor services by the Municipal Mayor from the Sangguniang Bayan pursuant to RA 7160 is a necessity.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
