RESOLUTION IMPLEMENTING MEMORANDUM CIRCULAR NO. 2002-010 OF THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT DATED SEPTEMBER 24, 2002, AMENDING SECTION 1 AND SECTION 3 OF MEMORANDUM CIRCULAR NO. 98-174 DATED SEPTEMBER 21, 1998 RE: COMPOSITION AND TERM OF OFFICE OF PEOPLES LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF MINA, ILOILO, PHILIPPINES

WHEREAS, pursuant to Memorandum Circular No. 2002-010 of the Department of Interior and Local Government dated September 24, 2002 known as Revised Rules of Procedure in the Hearing and Adjudication of Citizens complaints against uniformed members of the PNP before the Peoples Law Enforcement Board (PLEB);

WHEREAS, the present Peoples Law Enforcement Board (PLEB) has major changes in its composition, and term of office, hence reorganization of same is a must;

WHEREAS, by virtue of memorandum Circular No. 2002-010 of the Department of Interior and Local Government Rule II “entitled Creation, Function, Composition, Term of Office and quorum”. Composition of the PLEB shall be composed of the following:

- a.) Any member of Sangguniang Bayan chosen by his/her respective Sangguniang Bayan;
- b.) Any Punong Barangay had chosen by his/her respective Ligangmga Barangay;
- c.) Three (3) other members who are removable only for cause and to be chosen by the Local Peace and Order Council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a woman and another a member of the bar or in the absence thereof, a college graduate of the principal of the Central Elementary School in the locality. The Chairman of the PLEB shall be elected from among its members.

Term of Office – Term of Office of the members of the PLEB shall be for a period of three (3) years instead of two (2) years from assumption of office. Such members shall hold office until his/her successor shall have been chosen and qualified.

WHEREAS, all issuances, contrary to or inconsistent with this circular are hereby amended or repealed accordingly.

NOW, THEREFORE:
