SPECIFICALLY THE AMOUNT APPROPRIATED FOR THE PHILHEALTH  
INDIGENT PROGRAM TO FINANCE EXPENSES ON THE ANNUAL PASKWA  
HALAD SA BANWA CELEBRATION**

**WHEREAS**, the Paskwa Halad sa Banwa was declared an official annual Tourism Festival event of this Municipality per Resolution No. 2011-198-A dated November 16, 2011;

**WHEREAS**, the said event must be regularly sustained every year which will feature various programs and activities that can attract everyone, particularly foreign or local tourists coming in to witness the grand affair;

**WHEREAS**, the amount of One Million Pesos (P1,000,000.00) for Health Care Financing of the PhilHealth Indigent Program is considered savings under GAD plan appropriation as it duplicates the National Housing Targeting System-Poverty Reduction (NHTS-PR) program which is being financed by the national government; that the same can be used for other beneficial purposes such as the Paskwa Halad sa Banwa;
