There are 815 registered clean and active pantawid beneficiaries in the Municipality of Mina as of April 22, 2015 with an increase from its original 519 beneficiaries in 2011, it has grown in numbers due to series of validations that leads them under Set 7 grantees.

The year 2015 marked the 4th year of Pantawid Pamilya in the Municipality of Mina, a popular poverty alleviation reduction program. The goal was not only set to alleviate poverty but also to capitalize in human resources by empowering them in all aspects towards the improvement of their lives. The Bulig sa Kabuhi People's Organization was conceived by "Minanhons" as a response to a program entitled "Bulig sa Kabuhi Outreach Program" of the Mina Local Government Unit which started in 1993 when different forms of programs and services were extended by the LGU to all 22 barangays. At present, the Outreach Program is still on track as experienced during the occurrence of natural calamities such as Typhoons Frank in 1997, Quinta in 2012, Yolanda in 2013, and even Ruby in 2014.

However, to minimize dole-out services, an innovative program was developed by the Municipal Social Welfare and Development Office in partnership with the Department of Agriculture utilizing community organizing as a strategy. The social preparation in organizing The Bulig

Sa Kabuhi People's Organization started in early 2014. Initiating the concept of "Self-Help," community leaders comprising various sectoral groups previously organized by the MSWDO and Dept. of Agriculture such as Farmers Organization, KALIPI (Womens' Org.), Senior Citizens, PYAP (Youth Sector), Person with Disabilities, and The Pantawid Program (4 P's) were formed into a core group and eventually each of the 22 barangays formed a community organization. At present, there is already the "Mina Federation of Bulig sa Kabuhi People's Organizations" recognized by the Mina Sangguniang Bayan. Community organization is a means to empower the people so that they can be self-reliant and thrive in a self-managed community thru integrated and coordinated efforts.

BEFORE (actions that LGUs should do 48 hours

before the typhoon hits the areas), DURING AND AFTER each actions must be taken by the LGUs during and after the typhoon hits the area .Standards operating procedures must be followed and correctly observed to avoid panics and increase of casualties in times of disaster. The three Operation LISTO Minimum Critical Preparation Manual ALPHA, BRAVO and CHARLIE will be used by the Local Chief Executive to increase the resiliency in terms of disaster.



1. High Yield Technology Adoptation (HYTA) Program in Mina

The 'High Yield Technology Adoptation" (HYTA) program was crafted and implemented starting the Dry Season of CY 2014-2015 led by the DA-National Rice Program & implemented by the DA-RFO6 thru the Local Government Units involving the farmers' association in areas with good irrigation system.

In 2014 of the 2nd cropping, Municipality of Mina was able to plant hybrid rice seeds in 160 hectares irrigated rice areas and areas for wet season 2015.

The program envisions improvement in farm income, lessen production cost, give higher yield increment by using locally adapted

hybrid varieties and stimulation of employment in the rural sector through the use of this technology.

In the municipality, hybrid rice was already introduced but not in large scale due to some problems in technology adoption and seed sources. This HYTA program encourages the use of hybrid varieties in support to the Food Staple Sufficiency Program (FSSP) under the Agri-Pinoy Rice Program.

The seeds and fertilizers shall be targeted 300 hectares hybrid rice provided under a "grant-recoveryroll over" scheme which may include soil ameliorants/conditioner to be given as outright grant. The program will follow the "Plant Now Pay Later" scheme.

- 2. Received 103 bags certified seeds under Haiyan Assistance program with 103 bags UREA fertilizer.
- 3. Training on Production, Post-Harvest Mgt, Marketing, Processing and Storage of vegetables and other high value crops.



The Local Government of Mina in partnership with the 6-DA-AMAD DA-RFO OPA conducted this training to enhance the awareness, impart more ideas and techniques and presented the recent scenario in the community to encourage our vegetable farmers to produce more. This is in support to our




Food Production for Food Security Program.







The Municipality of Mina has been selected as one of the pilot areas for ASEAN's Adopt-A-Municipality (AAM) for Resilient Recovery Project. technical assistance project is being implemented by ASEAN in cooperation with the Office of the Presidential Assistant for Rehabilitation and Recovery (OPARR). Aside from Mina, the other participating LGUs are the Municipalities of Badiangan in the Province of Iloilo, and Municipality of Palo, Leyte and Ormoc City.

Mina's participants was headed by Mayor Rey P. Grabato who attended also the meeting with ASEAN – Ms. Marqueza Reyes prior to the workshop.

The focus of the project is the updating of the Comprehensive Land Use Plan (CLUP) of the Municipality of Mina to include the section on Disaster Risk Reduction and Climate Change Adaptation Measures following the HLURB - Supplemental Guidelines on Mainstreaming Climate and Disaster Risks in the CLUP.



It is observed that there are many patients admitted in different hospitals that needs blood, hence, Mayor Rey Grabato opted to hold bloodletting activity thrice a year to collect more blood. The Punong

Barangays from the 22 barangays of the municipality supported the program by bringing qualified volunteer donors. The personnel from Philippine Red Cross appreciated the support of the LGU thru Mayor Rey Grabato by giving priority to this kind of endeavor.

The volunteers have to pass the preliminary examination conducted by the screening team or PRC before they can be qualified blood donors. And once they are qualified, the hemoglobin testing and blood typing will be done prior to blood extraction.

The Regional Coordinator for adolescents and Team of DOH that focuses on the Adolescent and Youth Program from Mindanao visit Mina on April 20, 2015 to see the established functional community-based AYRH Clinic. They want to know how the LGU implemented the program and they were able to know the different health services offered by the Municipal Health Center to its constituencies including its complete Laboratory and diagnostic examinations conducted and a clinic intended for adolescents and youths.

Dr. Janeatte Sobrevega, Mina's Municipal Health Officer, gave a short briefing about the Referral system in handling teen moms from the community to RHU and to

Iloilo Provincial Hospital for proper management. The inter-agency referral system was a great help to the youths because it can immediately address their concerns. The reports as to the number of teenage pregnancy and other reproductive and health services offered to them are submitted to the Provincial Health Office and DOH-Region VI by Mina's Health Center.

After the clinic visit, the Team gave the Mina Health Office personnel forms to be filled up with some questions about the programs and their sustainability which they hope to replicate in their own provinces.

Finally, the Team went to Mina National High School where they visited, a the school - based Teen Center.
