# Gov. Defensor, Sr. leads Outstanding Minanhons

Hon. Arthur D. Defensor, Sr., the incumbent Governor of the Province of Iloilo leads the awardees of Outstanding Minanhons during the 50<sup>th</sup> Anniversary Celebration of Mina as a municipality on September 9, 2018. He was presented an award for Extraordinary Distinction in Lifetime Achievement by Mayor Rey P. Grabato and was conferred by Senator Aquilino "Koko" Pimentel III. The ward was handed to him personally by Senator Pimentel during the grandiose Awarding Ceremony held at the Mina Cultural Center.

Gov. Defensor was honored by his kasimanwas for his selfless dedication, true passion, unwavering commitment and

for his extraordinary consistent performance as a leader, upholding the highest esteem with dignity and honor of a public servant. Moreover, the compassion he demonstrated to his fellowmen through public service for over 50 years is unsurpassed and incomparable.

The previous and present municipal and barangay officials along with other Outstanding Minanhons in the different field of endeavors attended the ceremony.

Gov. Defensor was born to the late Santiago A. Defensor, of this place and Lourdes P. Doligosa of Dumngas, Iloilo who were both Public School Teachers. He started his elementary education in Mina

Central School and graduated his Bachelor of Laws Degree from the University of the Philippines in Diliman, Quezon City. A notable lawyer and has always been an achiever and bemedalled orator and debater. He started his political career as the First Elected Mayor of Mina in 1970 at the young age of 26. From then on his career flourished as an Assemblyman, Commissioner of the Presidential Commission of Good Government, Undersecretary of Department of Education Culture and Sports, Congressman and Governor of the Province of Iloilo for six terms. He is a recipient of various awards for his notable and exemplary accomplishments.

## SP commends Former Mayor Grabato

The Iloilo Sangguniang Panlalawigan through SP Res. No. 2018-590 commended Former Mayor Lydia E. Grabato of Mina, Iloilo for writing History: "Ang Maragtas Sang Mina" and a distinction of being the first Filipino woman to write a Municipal History Book in the whole Philippines. She is also honored as the second former municipal mayor to achieve the same feat, the first was Dr. Gregorio F. Zaide, former Mayor of the town of Pagsanjan, Laguna who wrote the book, Pagsanjan: In History and Legend.

The resolution, sponsored by Hon. Demetrio Sonza,

SP Member and Chairman Committee on Arts, Culture and History, cited the achievement of Former Mayor Grabato which can serve as an example and inspiration to other municipal mayors in the country.

The commendation was presented to Former Mayor Grabato by Vice Gov. Christine Garin in the presence of SP Members at the Session Hall, Iloilo Provincial Capitol on September 18, 2018.

The Book, a result of an extensive research done by Former Mayor Grabato was published and launched on September 8, 2018 and just in

time for the town's Golden Anniversary celebration. Great efforts were done to restructure the documentation of the history of Mina based on the official records from the National Archives of the Philippines and National Historical Commission. Added to the documentation were several records taken from the Archdiocese of Cebu City, Archdiocese of Jaro, Iloilo City, and libraries of University of the Philippines in the Visayas, University of San Agustin and from personal interviews. 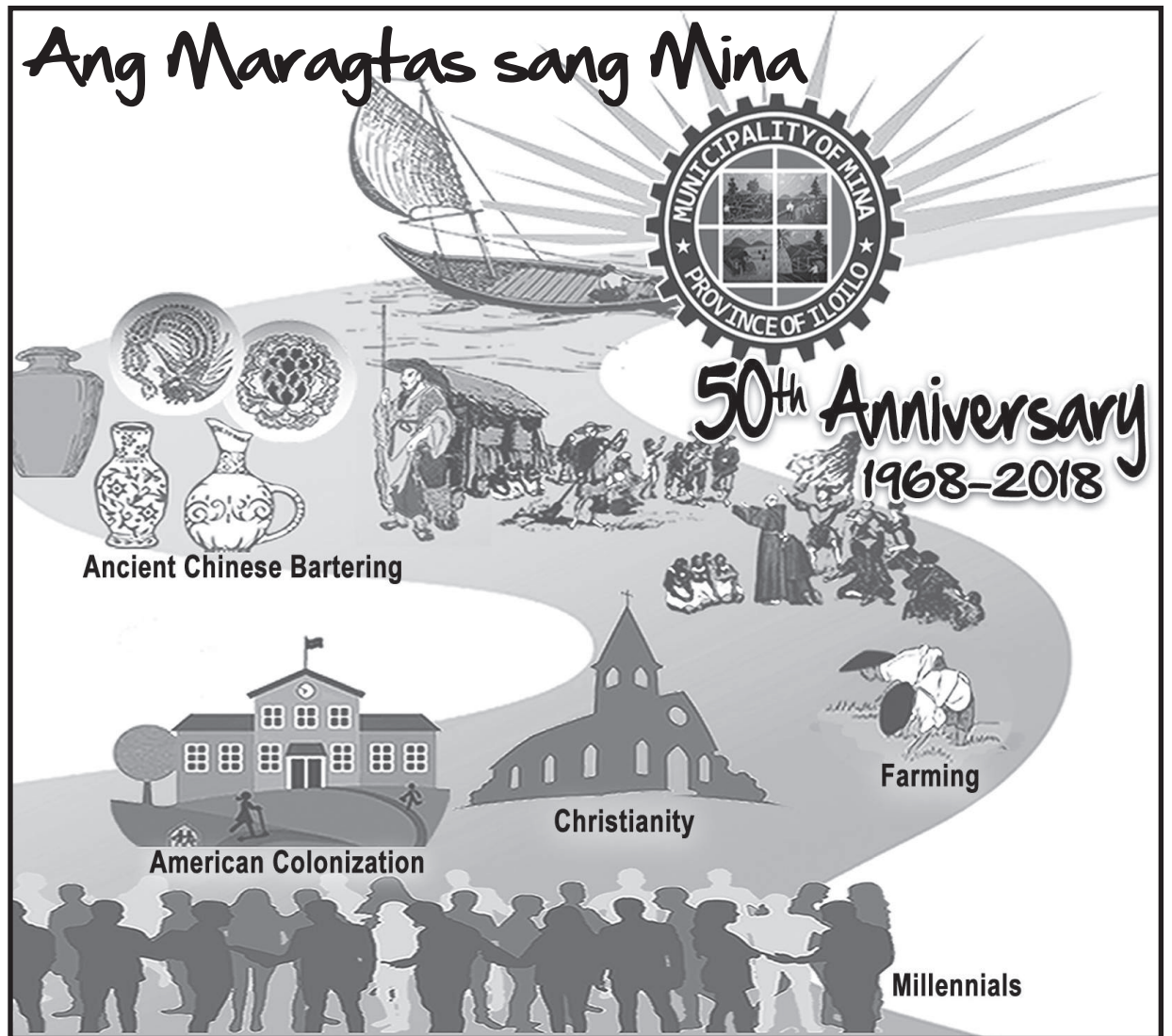

Sa pagsaulog sang ika - 50 nga anibersaryo sang Mina bilang isa ka banwa, ang Local Government Unit (LGU) sa pagpanguna sang aton halangdon nga Mayor naghimo sang tikang nga mahiwat ang ining kahiwatan nga madinuagon kag masadya. It depicts Mina's History from the Spanish era (1521-1898 to the American colonization (1898-1946) and until the time it was declared as a municipality on August 9, 1968. The extensive researches were done by the author, Former Mayor Grabato and assistance of Ms. Dory Emelo, Mina's Municipal Assessor. The LGU personnel, Miss Lida Magbanua and Mr. Manuel Armada, Jr. have remarkable contribution especially for the encoding and compilation of the photos included in the book.

The late Mrs. Luisa "Peachy" Garcia, an accredited translator and former Cataloger of the National Archive of the Philippines was responsible for the translation of the documents from Spanish to English language. On the other hand, the editing and organization of the contents of the history were done by Miss Rebecca Encarnacion, sister of Former Mayor Grabato.

The basic symbol of the Maragtas Sang Mina as shown in the cover of the book was originally conceptualized by SB Member Rose Karen Defensor and was enhanced by Ameliane Encarnacion.

## Ground Breaking of Mina - Jelicuon - Amiroy Road

On October 20, 2018 the Ground Breaking Ceremony of the project, Rehabilitation/Improvement of Mina – Jelicuon – Amiroy Road Phase I was held in Brgy. Amiroy, Mina. The 3.8 kilometers road has a project cost of P63,881,520.12 and the fund was from the Conditional Matching Grant to Provinces (CMGP) 2018. The rehabilitation works include concreting of road such as earthworks, sub-base and base course, concrete pavement, drainage and slope protection structures, and road signs, among others. The works are expected to be completed in April 2019.

The CMGP is a novel partnership program between DILG and DBM for provincial governments to partly address the seemingly poor state of provincial roads across the country and to improve the capacity of the provinces in local road management.

The ceremony was led by Gov. Arthur D. Defensor, Sr., SP Member Liecel M. Seville, DILG Representative Lynette Orquiola, Mayor Rey P. Grabato, Prov'l. Engr. Graciano Lucero and Rev. Fr. ## NSWMC officially approves LGUs 10-Year ESWM Plan

As mandated by the Department of Environment and Natural Resources (DENR) and as embodied in Republic Act 9003 otherwise known as Ecological Solid Waste Management Act of 2000, all local government units must come up with their respective Ecological Solid Waste Management (ESWM) Plan.

On October 18, 2018, the Municipality of Mina headed by

Executive Assistant V Lydia E. Grabato, presented the 10-Year ESWM Plan of the LGU before the panel members of National Solid Waste Management Commission (NSWMC) at Torre Venezia Suites, 170 Timog Avenue Corner Scout Santiago Street, Quezon city.

## BATA – eCIEMS wins in the 2018 eGov Awards

The entry of the Local Government Unit of Mina entitled BATA-eCIEMS or known as Budget, Accounting, Treasury, Assessment electronic Comprehensive Income and Expenditures Management System, won 3<sup>rd</sup> place in the National Search for 2018 eGov Awards under the Best in eGov Data Driven Governance (D2G) category. The eGov Awards now known as digital cities PH Awards is national search for Best Practices in Governance for LGUs held annually by Department of Information and Communications Technology (DICT), Department of Interior and Local Government (DILG) and National ICT Confederation of the Philippines (NICP). The award was presented to LGU-Mina, Iloilo on October 12, 2018 at Philippine International Convention Center, Manila.

The BATA-eCIEMS is a financial management tool which was conceptualized in Mina that transparently monitors the income and expenditures of the LGU for internal auditing and control and as the source of data for encoding in the LGU Integrated Financial Tool of the BLGF-DOF. The system is transparent to all offices concerned for viewing. The status of all transactions from income to expenditures can be examined by the offices that are linked with each other but can be accessed or opened only for inputting or updating by the personnel incharge of a specific area (budget, accounting,

treasury and assessor) using their own access codes. The application provides maximum transparency in local government financial management.

It is a complete user friendly computer software designed for a systematic and transparent corruption-free flow of financial transactions of Mina, Iloilo. It hasten up financial transactions from the start of its initiation to completion, where documentation is conducted in every aspect and duly recorded, thus, providing accuracy as to its status at any

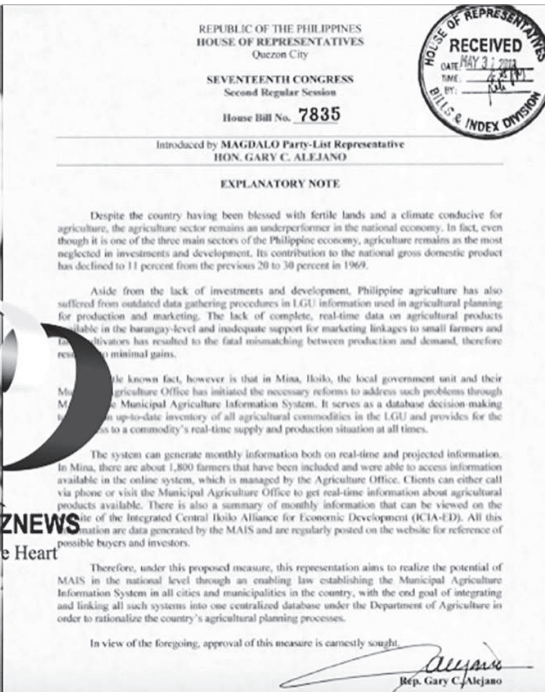
given point. Recording is also accurate because expenditures are immediately logged into its respective account. It provides the accurate status of the budget particularly the balances and proper posting into budget allocations, thereby ensuring that there will be no overcharging for each item and it also provides the decision-makers precise and accurate reports of the status of the balances of each item in the budget.

## Alejano files "MAIS BILL" to solve PH food security problem



In line with the recent crisis on food supply, Magdalo Representative Gary Alejano introduced House Bill 7835 or the Municipal Agriculture Information System (MAIS)<sup>1</sup> bill to solve supply-demand mismatch of local produce in the country.

Just this week, the local farmers from Kalayaan, Laguna had to discard more than 10 tons of tomatoes due to oversupply. It was reported that traders in Manila refused to buy the harvested tomato from the province because the supply was already enough. Meanwhile, rice shortage over the past weeks has been a cause of long queues for NFA rice rations across the country.

"Our food supply must correspond to our needs. We cannot afford to waste food when there are Filipinos who fall in line for too long just to get rations from the government.

This is precisely what MAIS tries to address. Open and accessible information regarding agricultural products in the market could aid in ensuring food security for every Filipino," Alejano pointed out.

The MAIS will contain agricultural information relevant to production such as supply and demand, production forecasts, crops databases, and a search engine to allow farmers to look for buyers and vice versa. Once adopted by Local Government Units (LGUs), MAIS will provide a national database which will aid decision- and policy makers in crafting necessary and appropriate actions to address issues relating to food security. In the long run, this system will expedite farm-to-market transactions.

The Magdalo Representative added, "This is not a band aid solution, but a long term solution that the President and

involved cabinet secretaries that need to address especially now with the unabated inflation that is heading to 7% based on the Bangko Sentral ng Pilipinas forecast."

"Since the beginning of Duterte's presidency, despite his claims that he will support the agricultural sector, the Department of Agriculture has never been a priority as shown in the low budget allocation of the agency. It is also unfortunate that the sector remains an economic underperformer despite the Philippines being an agricultural country. Through this proposed solution we will be able to support our local farmers and secure food supply for everyone. MAIS will level the playing field in production. This is a step in guaranteeing there will be no shortages and overproduction in the future," Alejano concluded.

S. Hernando, Provincial Field Team Lead-Iloilo, Ms. Rose del Rio and Ms. Yen de Felipe as the Resource Person in the Rural Impact Sourcing Technical Training (RISTT).

The RIS benefits jobless individuals in the countryside. It looks beyond the common source of supply for traditional outsourcing to provide higher-income employment and access to new income opportunities to individuals that might not otherwise be employed in this sector. These individuals are typically people who are at a unique disadvantage and lack

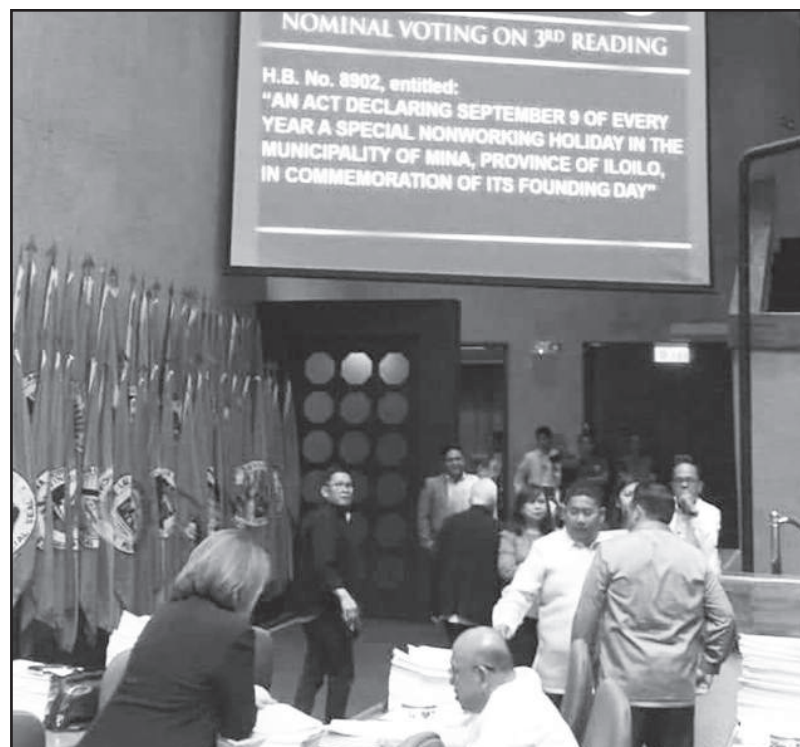
access to traditional employment. To be able to help address unemployment in the country and support more Filipinos in the countryside gain employment through the online freelancing industry, the DICT has developed a module that will provide technical training on ICT-related jobs. The training primarily aims to increase people's hire ability by focusing on development and improvement on their ICT skills and utilize it for employment opportunities. Further, this training recognizes the role of the Micro Small Medium Enterprise (MSMEs) to provide employment opportunities and contribute to economic growth especially within their locality. By increasing competency of the talent, this training will also serve as an avenue to promote the use of e-Commerce by MSMEs.

Eventually, the success in the ICT-related job will provide economic opportunities not just for the graduates but as well as the people who will directly and indirectly benefit in this initiative.

# MUNICIPAL AGRICULTURE OFFICE



**FARMER LIVESTOCK SCHOOL- SUSTAINABLE PIG FARMING:** Agricultural Training Institute through the Mina Municipal Agriculture Office conducted Farmer Livestock School at Montogawe Eco Park. 24-farmer beneficiaries are able to complete the 18 weeks of training on Livestock Management. The aim of this training is to teach farmers increase their income using new innovative skills in raising livestock in a sustainable way.



**RICE MODEL FARM FOR HYBRID VARIETIES:** Rice Model Farm in Barangay Agmanaphao showcase the performance of five (5) hybrid varieties of rice to a site specific approach. This kind of approach able to determine (1) the adaptability of the hybrid rice to the prevailing climate in the locality, (2) resistance to pest and disease, (3) growth base on recommended fertilizer and (4) crop yield.



**INTEGRATED COMMUNITY FOOD PRODUCTION:** 220 recipients from the 22 Barangays of the Municipality of Mina are provided by vegetables seeds garden tools . The objective of the program is to mitigate hunger, poverty and malnutrition among our poor families in our municipality.



**COMMUNITY SEED BANKING:** Community Seed Banking is a strategy developed by the Department of Agriculture to provide low cost high quality seeds to farmers. It was established in June 2018 through the AgriDoc project of the ATI in partnership with the Brgy. Janipa-an East Farmers Association through Mina Municipal Agriculture office. The aim of this project is to reproduce good quality seeds in the community, increase income and higher rice production and improve quality of life of the farmer.



**CORN SEEDS DISTRIBUTION:** Department of Agriculture through Mina Municipal Agriculture allocates 35 bags of Hybrid Corn seeds. It aims to provide farmers good quality and high yielding varieties of corn to increase the income of our corn farmers.



**PHILIPPINE CROP INSURANCE CORPORATION (PCIC):** Philippine Crop Insurance Corporation is an attached agency of the Department of Agriculture wherein its mandate is to provide insurance protection to farmers against losses of their palay and corn and other crops. 16 farmers with damaged rice fields was able to get claims from Crop Insurance Corporation.

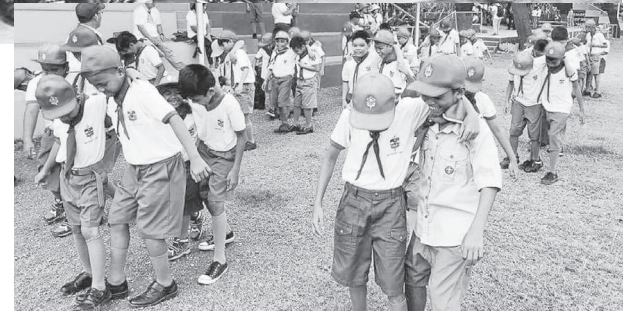

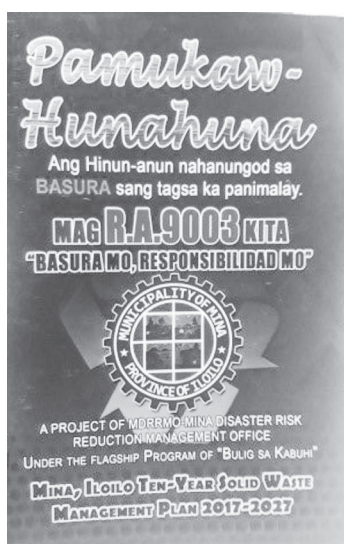

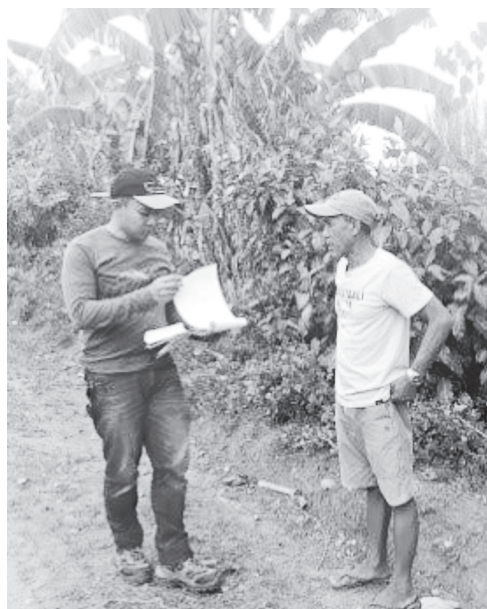

### MINA PUBLIC MARKET

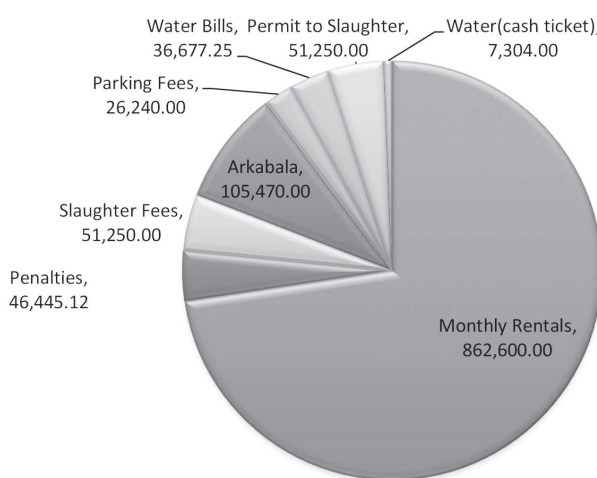

This means efficiency in doing our routine tasks which include: maintenance of cleanliness in the whole market premises, securing entrances and exits during night and opening it on time during the day and most importantly, attending to the vendors and consumers concerns and finding ways to solve them.

## PTO conducts Public Auction Sale in Mina

The Iloilo Provincial Treasurer's Office (PTO) in coordination with the Office of the Municipal Treasurer, conducted its Public Auction Sale for the Delinquent Real Properties located in Mina, Iloilo on December 20, 2018. It was held at the Mina Municipal Hall Lobby and was attended by PTO Representatives, Mr. Hamlen Gualin and Ms. Lovella Valderrama with the Municipal Treasurer, Mr. Romeo Tabarnilla and his staff. Present also were the interested registered bidders and other guests who came to witness the proceedings of the Public Auction Sale.

The program started at exactly 10:00 o'clock in the morning with an Opening Prayer by Mr. Benjie Pelobello, MCR Staff. Mr. Romeo F. Tabarnilla, gave his welcome message and declared the formal opening of the Public Auction Sale. It was learned from Mr. Tabarnilla that a total of 1,125 Notices of Delinquencies were distributed to owners of delinquent real properties located in the different barangays in Mina while out of these number, 119 real properties were left unpaid and were issued Warrant of Levy. Then after some of these property owners settled their tax delinquencies upon

receiving Warrant of Levy, only 7 lots were left and underwent publication for two (2) consecutive weeks in the newspaper of daily circulation. Finally, after the completion of several processes, only 4 lots were left without any payments of their taxes and eventually, they were subjected for public bidding.

Ms. Lovella Valderrama of PTO, explained the rules, regulations and conditions of the Public Auction Sale, while Mr. Hamlen Gualin, conducted the public bidding and the sale was made by oral bidding or viva voce.

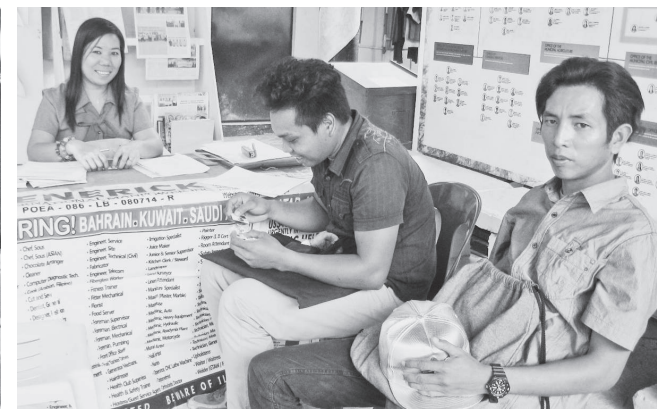

For the final six (6) months of FY 2018, the Office of the MPDC accomplished many things and they were as follows:

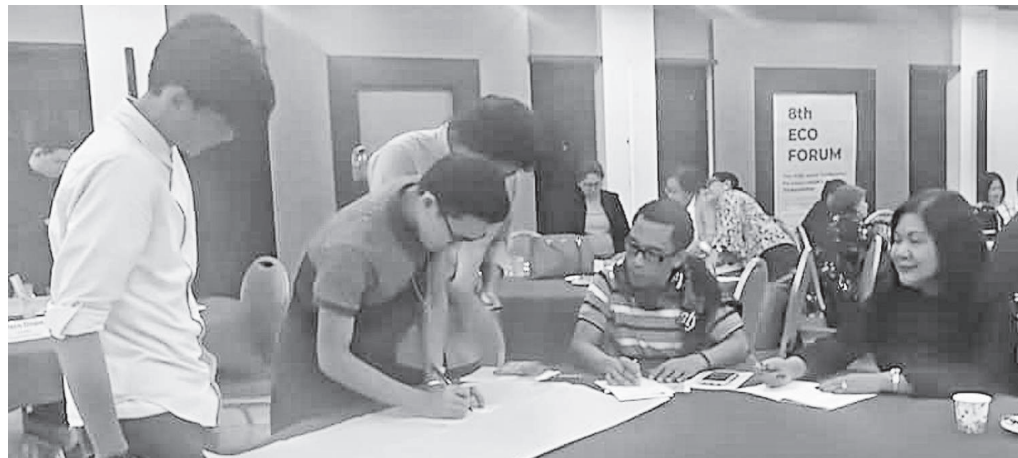
- The Annual Investment Plan 2019 was accomplished and submitted to the office concerned on the specified period.

# MUNICIPAL HEALTH OFFICE



**SCHOOL BASED IMMUNIZATION.** Immunization of Grade 1 pupils of Measles-Rubella and Tetanus Toxoid, Diptheria (TD) vaccines. HPV Vaccine to Grade 4 female students and TD vaccine to Grade 7 students in all 12 elementary schools and one high school in the municipality with accomplishment of (MR) 44%, (TD) 96% in elementary and (MR) 61%, (TD) 61% in high school while HPV has 81%. About 17 % (HPV), (MR) 4 % (TD) 4 % (Elementary), (MR) 10%, (TD) 10 % (High School) were not given immunization.



## BLOODLETTING ACTIVITY

Conducted the 3rd bloodletting activity with 116 units of blood accumulated from successful donors. Done three times a year with target output of 1% of the total population.

With a population of 24,632 in 2018, 300 units of blood were collected during the 3 bloodletting activities or with a recorded 1.2% accomplishment. This is due to the full support of the municipal officials headed by Mayor Rey Grabato and with the cooperation of barangay officials.



TSEKAP activity done by the DOH deployed personnel, midwives and dentist. They conducted physical examination, BP check-up and oral examination. Identified medical illness are being referred to RHU or nearest health facility with their proper coordination or guidance by the health workers.



Conducted 3-day training on Interactive Intervention Strategies on Peer Helping to the 8 chosen Out-of-School Youth Adolescents in coordination with the Provincial Population Office.



DOH National Team conducted evaluation for accreditation of the AYRH Clinic for 3rd Level Adolescent Health Friendly Facility, the first RHU in Iloilo to undergo such accreditation.



Graduation Ceremony of the Community-Based Rehabilitation Program – Out of 87 PWUDs, 71 were able to make it to the ceremony and was attended by Mayor Rey Grabato, Vice Mayor Bernardino Chichirita, SB Members and Punong Barangays.
