RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LOCAL GOVERNMENT UNIT OF MINA AND THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY HON. ARTHUR D. DEFENSOR, SR., ON SAFE CLOSURE AND REHABILITATION OF DUMPING SITE/DISPOSAL FACILITY

WHEREAS, presented for consideration is the letter from the Office of the Mayor, Mina, Iloilo requesting authority from this Sanggunian to sign by the Municipal Mayor in the Memorandum of Agreement (MOA) for the implementation of Safe Closure and Rehabilitation of the disposal/dumping site in the Municipality of Mina;

WHEREAS, Republic Act No. 9003 (RA 9003) otherwise known as the “Ecological Solid Waste Management Act of 2000” was passed and made into a law in 26th Day of January 2001; pursuant to the provision of RA No. 7160, otherwise known as the Local Government Code, the LGU’s shall be the primary responsible for the implementation and enforcement of environmental laws;

WHEREAS, under R.A. 9003, LGU’s are mandated to implement the aforementioned law, in 2003 the Province of Iloilo has adopted the “Ecological Solid Waste Management Program” and the program promote proper solid waste management in the whole Province and ultimately help in eradicating problems caused by garbage;

WHEREAS, DENR Administrative Order No. 2001-34 known as the Implementing Rules and Regulations of RA 9003, are promulgated to prescribe the procedures and guidelines for the implementation of the law and set guidelines on Closure and Rehabilitation of Disposal Facility;

WHEREAS, the Municipality of Mina is one among the five (5) municipalities that were issued with Notice of Violation from the DENR-Ombudsman as to the non-compliance on the provisions of RA 9003 specifically on the closure and rehabilitation of disposal dumping site;

WHEREAS, the parties hereto agree and declare their commitment to take the necessary steps to implement the principles and objectives provided for, in the agreement, hence this Resolution.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LOCAL GOVERNMENT UNIT OF MINA AND THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY HON. ARTHUR D.
