RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT WITH INFORMATION AND COMMUNICATION TECHNOLOGY OFFICE (ICTO) WITH PRINCIPAL OFFICE AT ICT OFFICE BUILDING, ZAMORA STREET, ILOILO CITY, REPRESENTED BY ITS CLUSTER DIRECTOR, FREDERICK D.C. AMORES FOR THE IMPLEMENTATION OF FREE WI-FI INTERNET ACCESS IN PUBLIC PLACES PROJECT

WHEREAS, the national government through the DOST-ICTO is undertaking the Free Wi-Fi Internet Access in Public Places Project across the Philippines to accelerate economic, social and educational opportunities;

WHEREAS, the Project is envisioned to provide Wi-Fi internet access in public places nationwide, but will initially cover selected cities and municipalities and public places such as Public Schools, Libraries, Hospitals, Rural Health Unit, Police Stations, etc.;

WHEREAS, the DILG, together with the LMP and DOST, have agreed to cooperate and jointly commit in promoting development through the use of information and communications technology for effective and efficient governance in the country;

WHEREAS, a MOA between the two parties above-mentioned shall be executed in the pursuance of this undertaking hence this authority to sign by the Municipal Mayor from the Sanggunian pursuant to Section 447 (1)(iii) of RA 7160.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
