**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE No. VI, REPRESENTED BY ITS OFFICER IN CHARGE, SALOME O. SIATON, FOR THE IMPLEMENTATION OF DOLE LIVELIHOOD (KABUHAYAN PROGRAM) IN THE MUNICIPALITY OF MINA AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (P500,000.00)**

**WHEREAS**, presented for consideration to the August Body is the Authority of Mayor Rey P. Grabato to enter into a Memorandum of Agreement (MOA) with Officer in Charge, Salome O. Siaton, as regard to the implementation of DOLE LIVELIHOOD (KABUHAYAN PROGRAM);

**WHEREAS**, the DOLE is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

**WHEREAS**, the DOLE provides capacity building facility on livelihood and entrepreneurial ventures for the workers in the informal economy and the vulnerable groups of workers such as parents of child laborers, women, youth, persons with disabilities, indigenous people, among others, under the DOLE LIVELIHOOD (KABUHAYAN) PROGRAM, pursuant to the provisions of DO No. 137-14, series of 2014;

**WHEREAS**, the DOLE-RO VI has been given the responsibility to implement the DOLE livelihood (Kabuhayan Program) to enable the unemployed poor, seasonal and low wage workers to start individual livelihood or collective enterprise undertakings with the goal of moving them out of poverty and making them productive;

**WHEREAS**, the project identified to this effect is the Catering Service and Canteen Operation Project located in the Municipality of Mina;

**WHEREAS**, R.A. 7160 otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor may represent the Municipality and sign in its behalf in contracts, obligations and other documents upon authorization by the Sangguniang Bayan, hence this Resolution.

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE No. VI, REPRESENTED BY ITS OFFICER IN CHARGE, SALOME O.
