## RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BFP OR SOURCE AGENCY (SA) REPRESENTED BY OIC-CSUPT. BOBBY V. BARUELO (DSC), BFP FOR THE UTILIZATION OF LGU 20% SHARE ON FIRE CODE REVENUES COLLECTIONS

WHEREAS, BFP, through DOF-DBM-DILG Joint Circular No. 2015-01 dated February 12, 2015, is hereby authorized to release the twenty percent (20%) share in the Fire Code Revenues to concerned cities/municipalities upon release of SARO/NCA from them Department of Budget and Management (DBM) from collections for CY 2010, 2011, 2012 and 201. CY 2014 to 2015 collections will be directly released by the DBM to the City/Municipality;

WHEREAS, the Municipal Government of Mina shall appropriate the twenty percent (20%) share exclusively for the improvement and maintenance of Municipal BFP fire station to include acquisition of firefighting equipment, service vehicles, investigative equipment, rescue equipment, office equipment, office furniture and fixtures and construction/repair of municipal BFP fire station;

WHEREAS, BFP and LGU of Mina shall ensure the effective collection of Fire Code Revenues and efficient allocation of the same for the improvement of Municipal BFP fire station, through a Memorandum of Agreement;

WHEREAS, an authority to sign in the MOA by the Municipal Mayor from this Sanggunian is needed pursuant to Section 447 (a)(iii) of RA 7160.

## NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
