RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A CONTRACT OF WORK WITH BILLENA CONSTRUCTION REPRESENTED BY ADOLFO L. BILLENA, OWNER/PROPRIETOR, WITH BUSINESS ADDRESS 11 FUENTES ST. ILOILO CITY FOR THE: 1.) SITE DEVELOPMENT FOR PABAHAY NG MINA, AND 2) CONSTRUCTION OF COMPREHENSIVE DRAINAGE SYSTEM

WHEREAS, presented for consideration is the letter request from the Mayor's Office requesting authority to sign in the contract from this Sanggunian pursuant to Section 444 (b) (vi) of R.A 7160, also known as the Local Government Code of 1991;

WHEREAS, the LGU of Mina is a recipient of the fund coming from National Housing Authority for housing project with local counterpart of Two Million Pesos (P2,000,000.00) for the development of the site owned by the municipal government of Mina for the said housing project;

WHEREAS, the LGU of Mina, is likewise, a recipient of the fund amounting to One Million Pesos (P1,000,000.00) for the Construction of Comprehensive Drainage System from the BuB 2016, in the municipality's town proper;

WHEREAS, both projects were submitted to a public bidding with the above-stated contractor as the winner to whom such projects were awarded for implementation.
