**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A CONTRACT OF WORK WITH NOE'S BUILDERS, REPRESENTED BY NOIMI GEVERO, PRESIDENT, WITH BUSINESS ADDRESS AT LAPAZ-BANTUD STS, INGORE, ILOILO CITY FOR THE 1.) REHABILITATION OF ROOFING OF PUBLIC MARKET, AND 2.) CONSTRUCTION OF HOME ECONOMICS OF MINA NATIONAL HIGH SCHOOL**

WHEREAS, presented for consideration is the letter from the Office of the Mayor requesting authority from this Sanggunian to sign in the Contract of Work with the Noe's Builders, pursuant to Section 444 of RA 7160;

WHEREAS, the Municipality of Mina has available fund for the rehabilitation of Public Market Roofing amounting to Three Million Pesos (P3,000,000.00), ready for implementation;

WHEREAS, another project also ready for implementation is the Construction of Home Economics Building with a total cost of Three Million Pesos (P3,000,000.00), of which, One Million Pesos (P1,000,000.00) came from the assistance released by the Chinese Ambassador to the Philippines, another One Million Pesos (P1,000,000.00) came from the Iloilo provincial government fund and the remaining One Million (P1,000,000.00) is being financed by this LGU;

WHEREAS, the above two projects were submitted to a public bidding and the winner was the Noe's Builders to whom these projects were awarded.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
