**ORDINANCE NO. 2016-299**

**AN ORDINANCE TO FURTHER DEVELOP AND CONVERT THE BUILDING INTO A MULTIPURPOSE ASIDE FROM BEING AN EVACUATION CENTER AS ITS PRIMARY PURPOSE**

**WHEREAS**, the Municipality of Mina was a recipient of the PCF from the Seal of Good Housekeeping for the year 2014 amounting to One Million Pesos (P1,000,000.00) for the construction evaluation center;

**WHEREAS**, the said amount did not suffice the completion of center thus, in order to complete the project, the LGU of Mina appropriated another One Million Pesos (P1,000,000.00) from the 20% development fund to make a total of Two Million Pesos (P2,000,000.00) project cost;

**WHEREAS**, came the search for Legislative Award in 2015, and among the criteria needed was the presence of the Session Hall and individual offices of the Municipal Vice Mayor and the Sangguniang Bayan members;

**WHEREAS**, with no other resource, the Sangguniang Bayan decided to convert the building into multi-uses including to use it as session hall without depriving its primary purpose as evacuation center more particularly records and documents computers, etc., of the Mina Town Hall offices located at the ground floor of the building.

**NOW, THEREFORE:**

**BE IT ORDAINED** by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

**Section 1.** This Ordinance shall be called “An Ordinance Converting an Evacuation Center into Multipurpose Building and a Session Hall.”

**Section 2. Declaration of Policy.** It is hereby the policy of the Municipality of Mina to protect the general welfare of its constituent as well as official records/documents of the day to day transactions of the LGU and to increase more efficiency and effective in the local governance.

**Section 3.** When use in this Ordinance, the following terms shall be define:

- a.) **Multipurpose** - shall mean that the usage of the building shall be opened for some other uses other than evacuation center like, session hall, conference and function room.
- b.) **Evacuation Center** - temporary shelter for displaced disaster affected offices and staffs operation and a place for safekeeping of records and equipments at times of calamity or disaster especially during flash floods.
- c.) **Session Hall** - a room where the Sanggunian hold sessions, it may be regular or special.

**Section 4.** The building shall remain as the evacuation center one day before, during and after the occurrence of disaster after which when things returned to normal, it shall be used as session hall, conference room and function room for seminars being held by the municipality.

**Section 5.** This Ordinance shall be effective upon approval.
